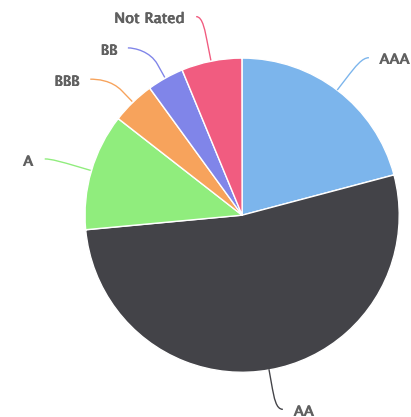

Maturity Distribution (%)¹²

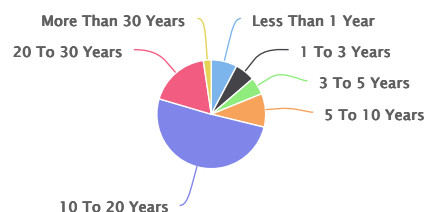
