## The Fund

The Fund seeks to provide both current income and long-term growth of capital by investing in a combination of common stocks and fixed-income securities. Typically, the Fund will allocate between 50% and 75% of its net assets to equity securities (via Stock Portfolio) and between 25% and 50% of its assets to fixed-income securities (via Core Bond Portfolio).<sup>1</sup>

## The Approach

The Fund's equity portfolio employs a fundamental, research-driven approach, investing in companies with a broad range of market capitalizations. The Fund's fixed-income portfolio employs a relative value framework, which provides the basis for determining the attractiveness of investments in government, corporate, mortgage-backed and other securities. The portfolio managers meet periodically to determine the percentage of Fund assets to be invested in each portfolio, based on market and other factors.

## The Features

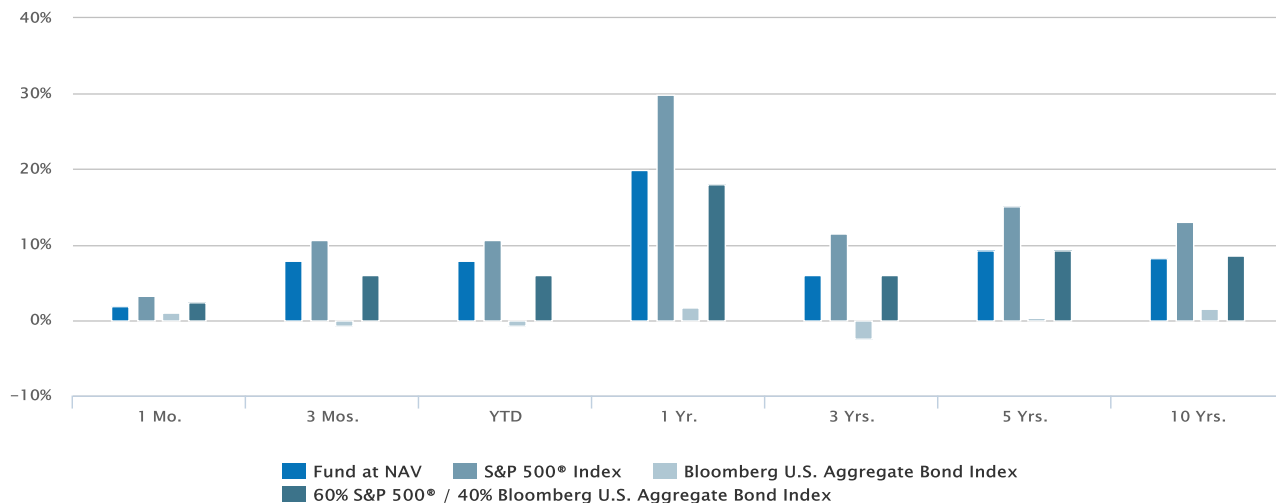
The Fund leverages the expertise and collaboration of three experienced portfolio managers, offering a professionally managed mix of stocks and bonds generally considered the cornerstones of a diversified portfolio in a single fund. 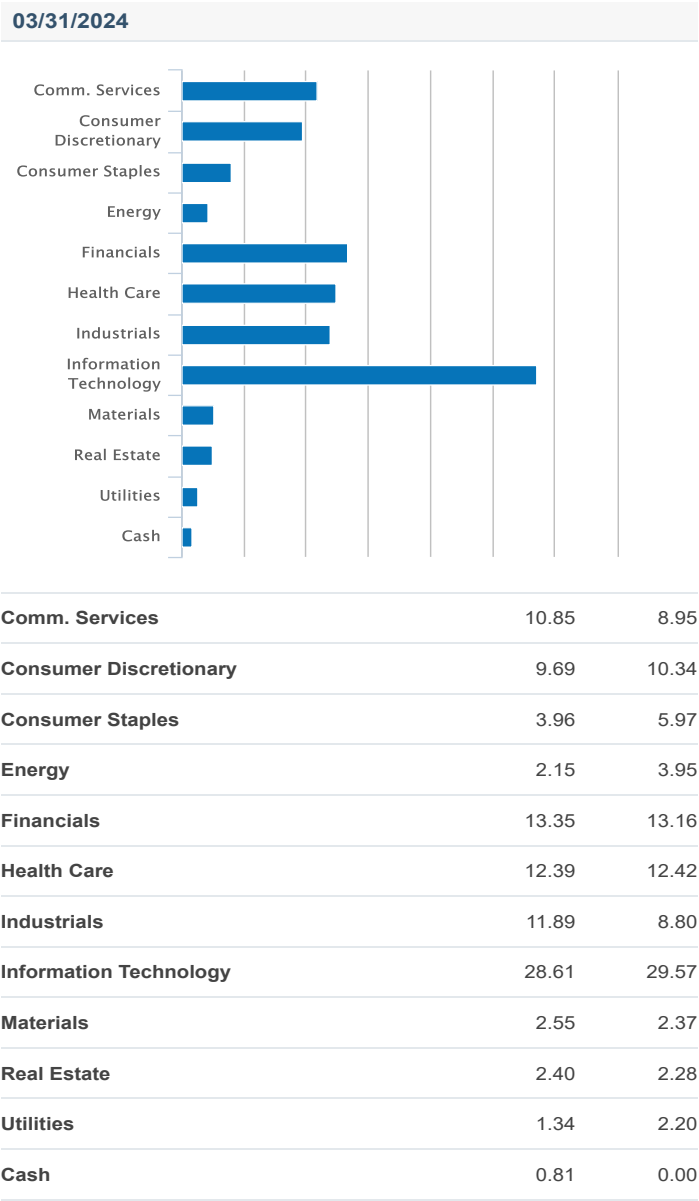
