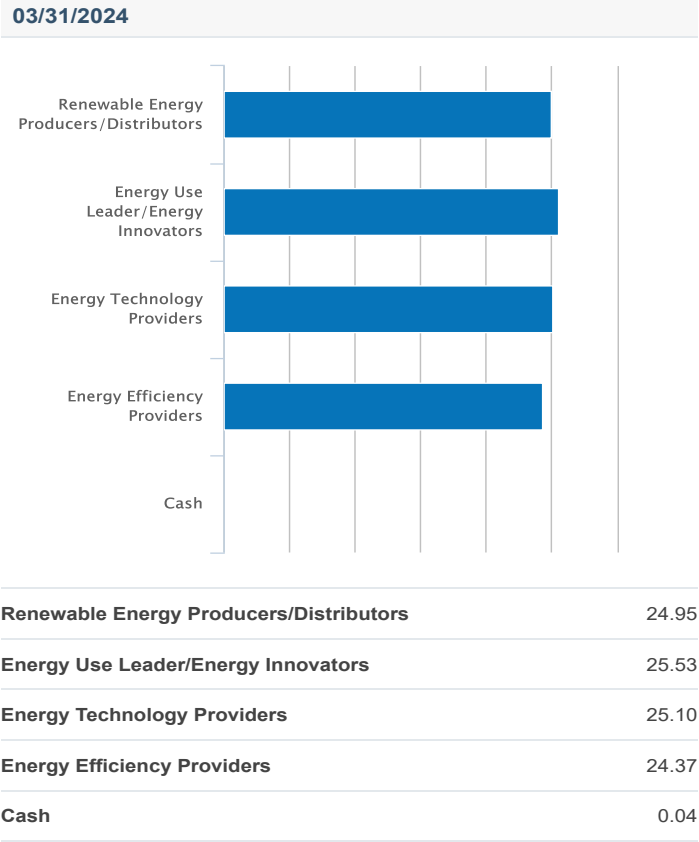

Category Weightings (%)<sup>8</sup>



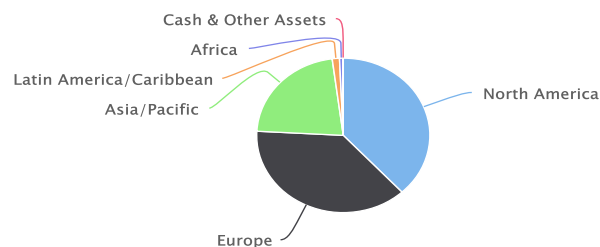
