In-depth, bottom-up credit research and broad diversification<sup>1</sup> are this Fund's cornerstones, managed by one of America's largest and most experienced loan managers.

## The Features

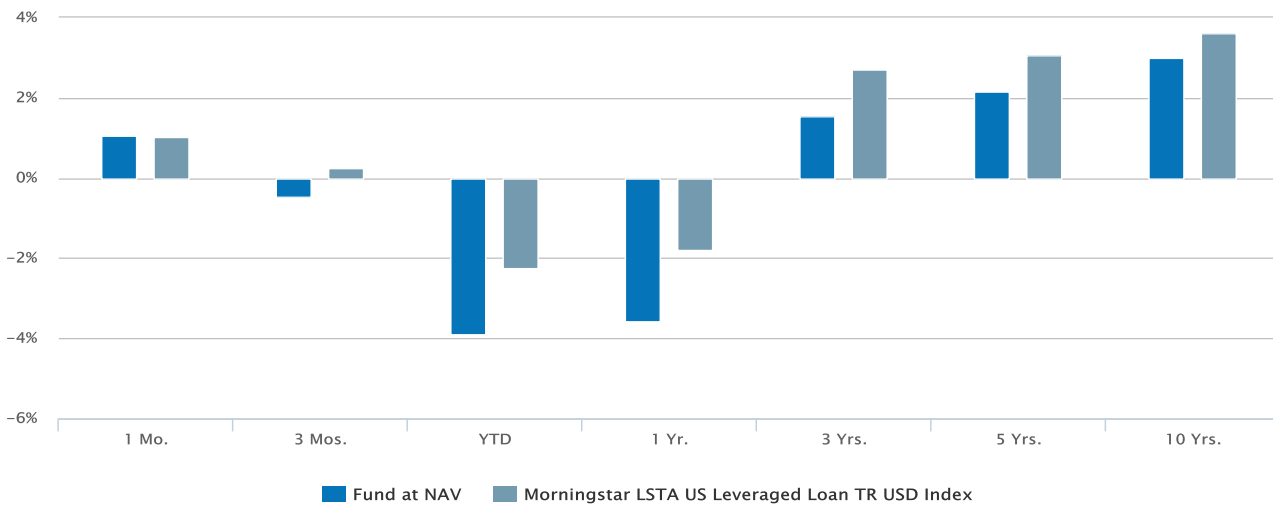

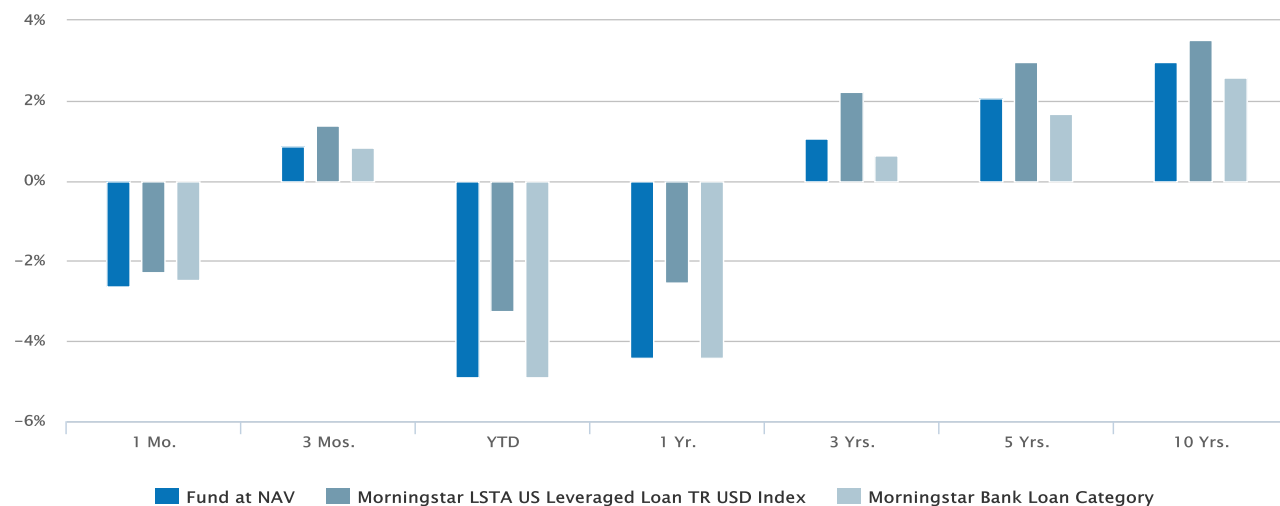

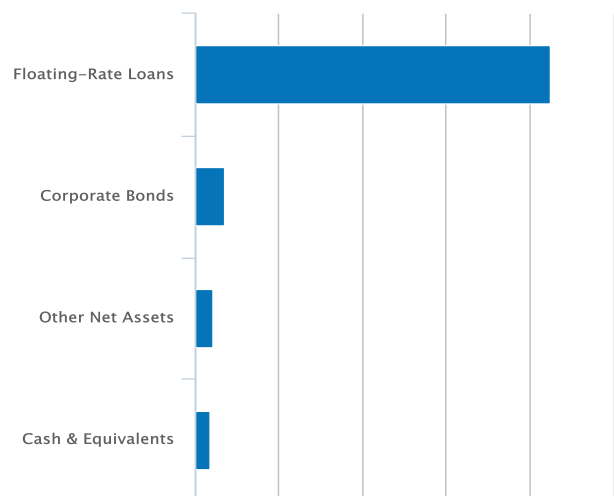

## RISK CONSIDERATIONS
