Asset Mix (%)⁴

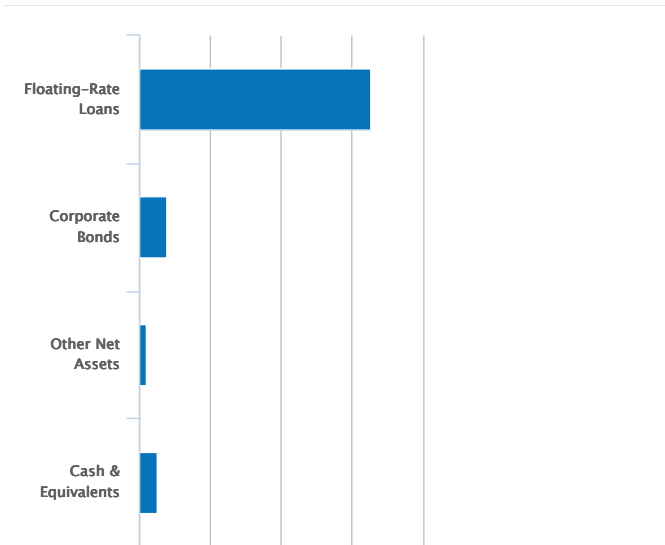

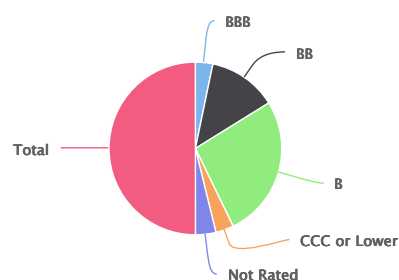

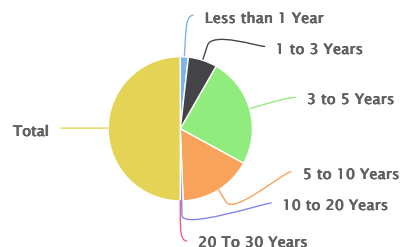
