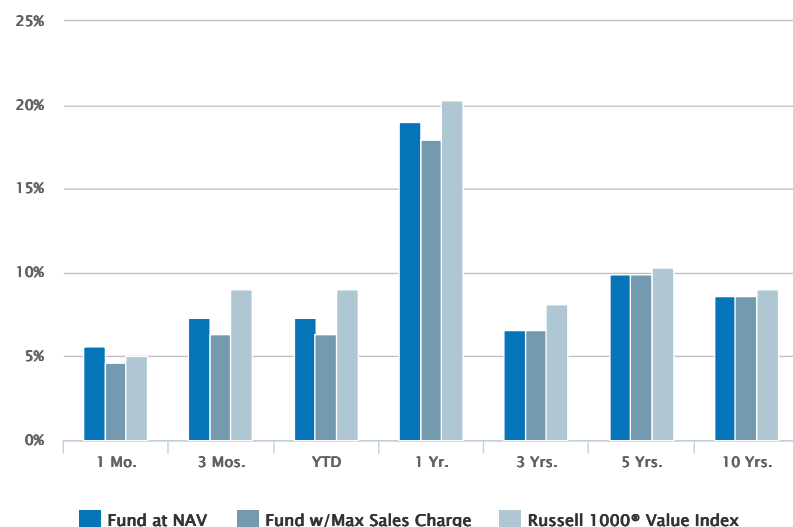
The Features

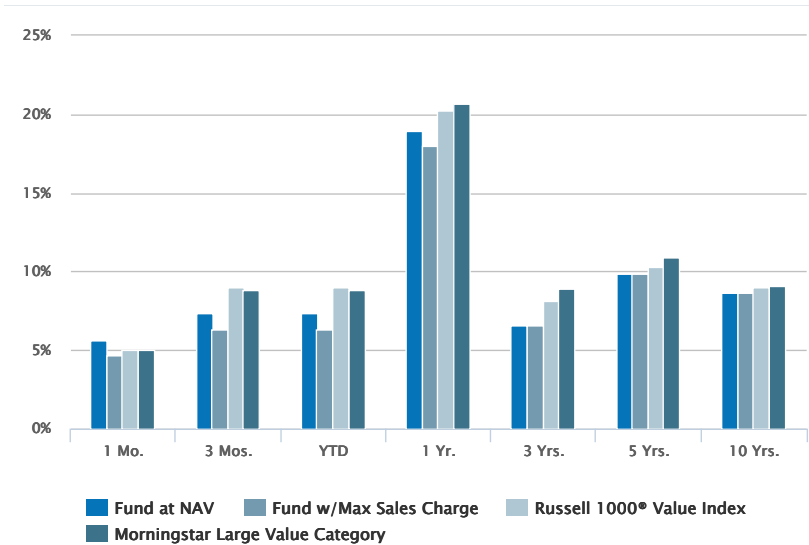

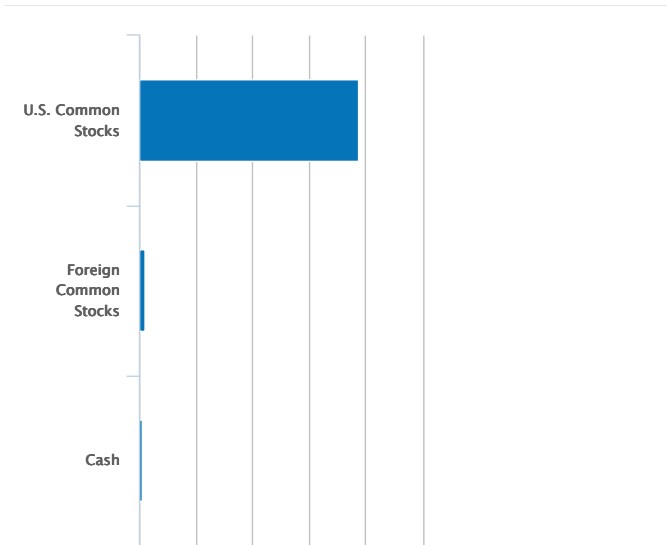

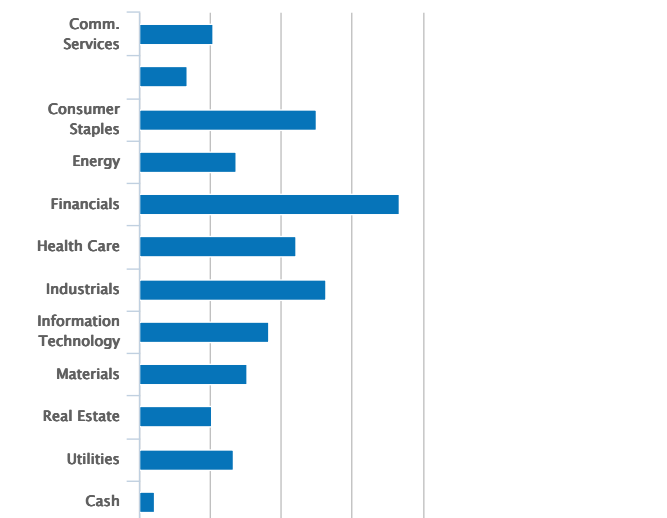
