Asset Mix (%)³

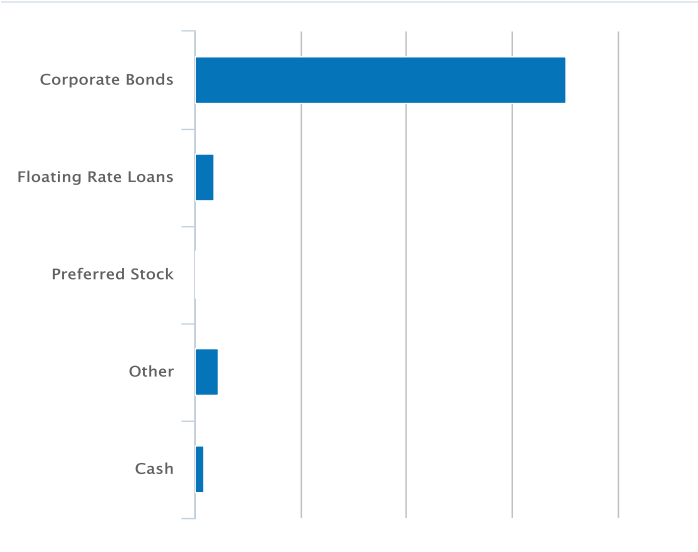

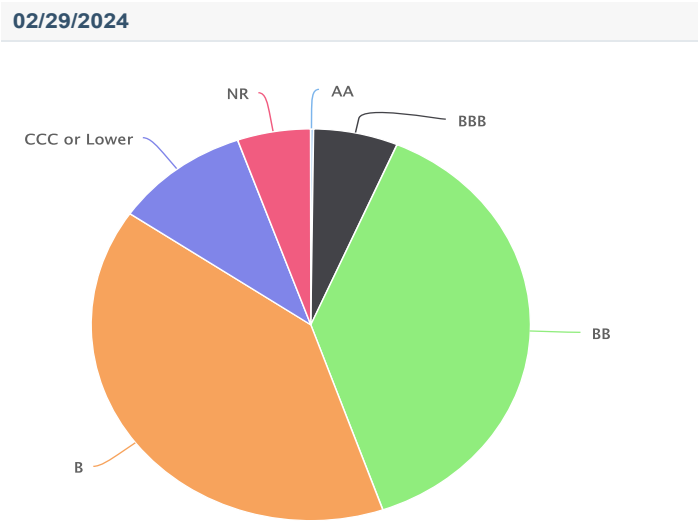

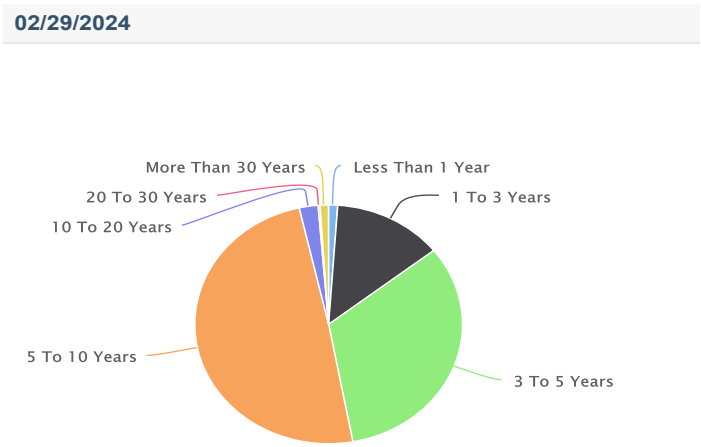
