Experienced Leadership Team

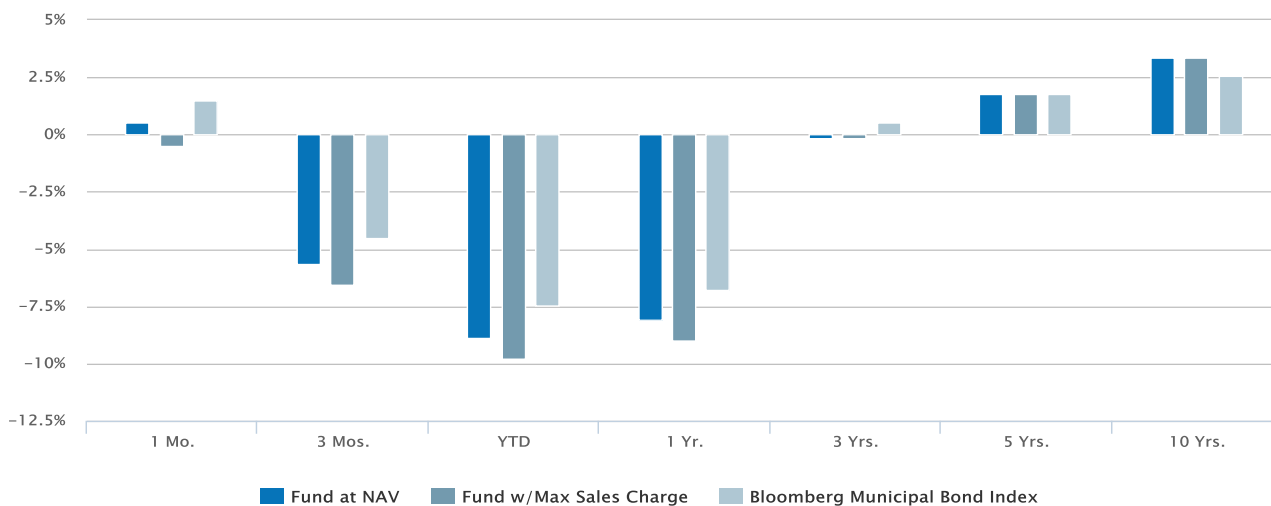

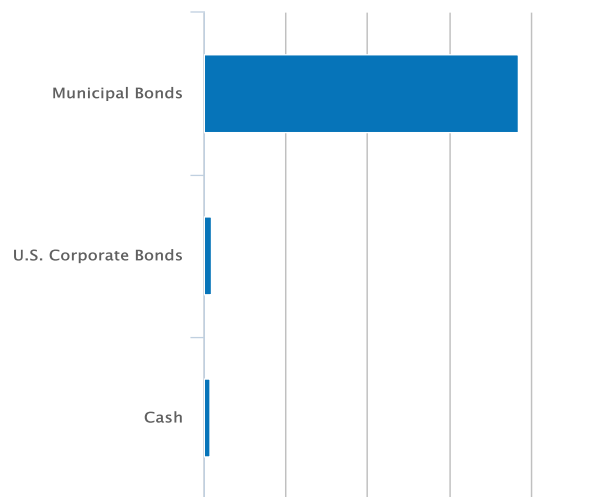

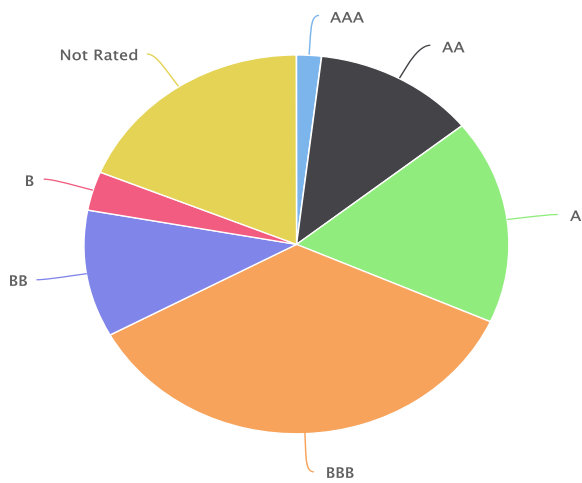

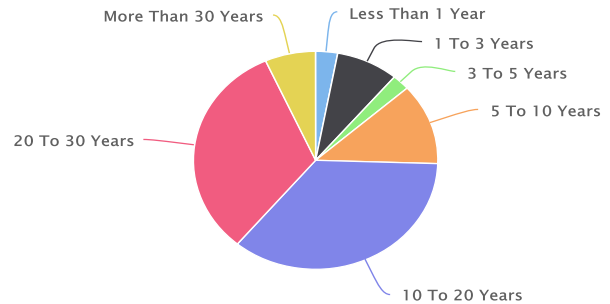
Maturity Distribution (%)¹¹
