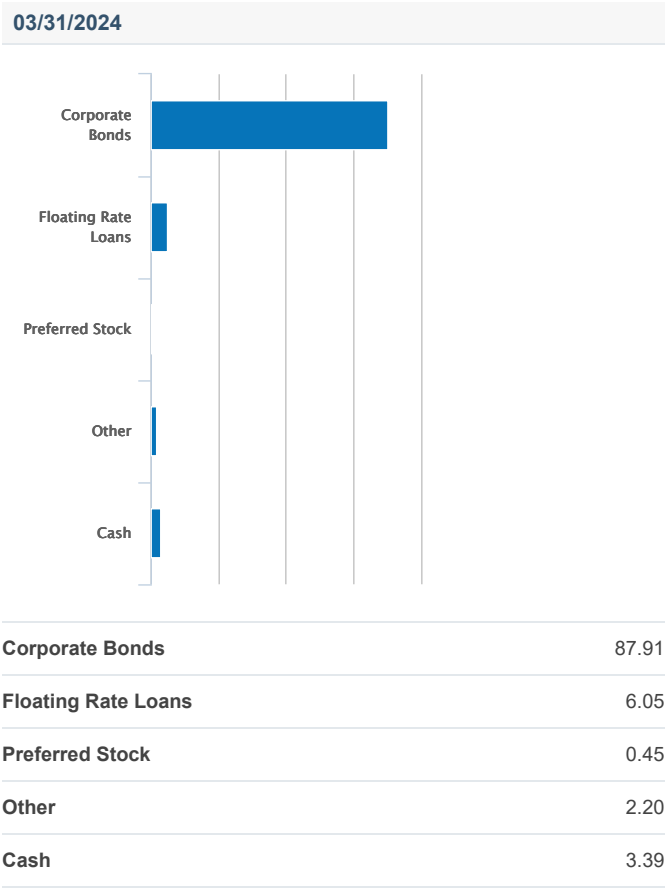

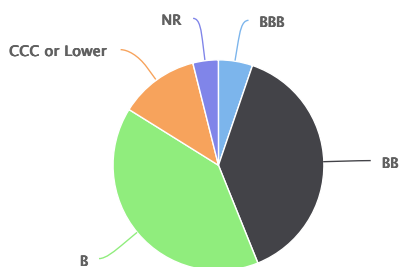

Maturity Distribution (%)⁴

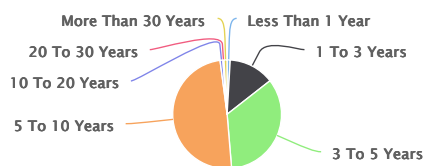
