## The Features

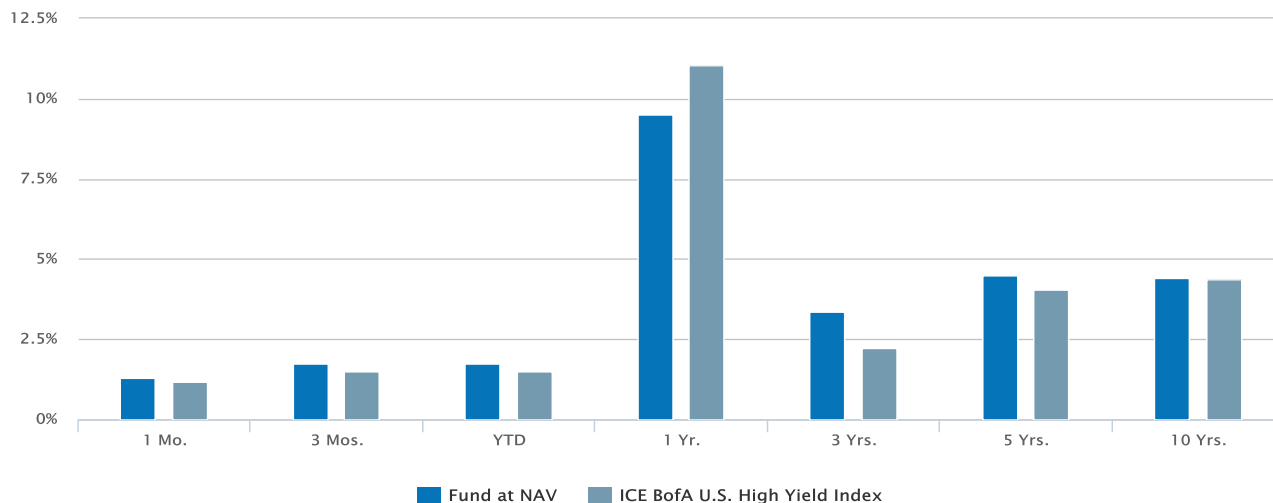

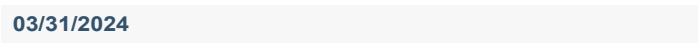

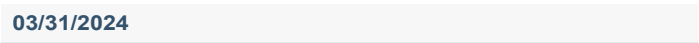

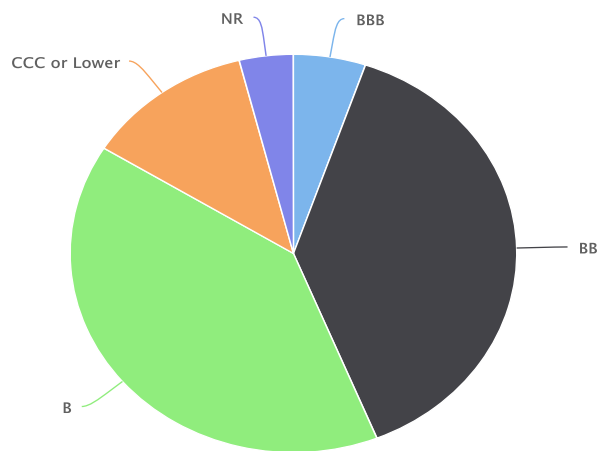

Maturity Distribution (%)<sup>4</sup>

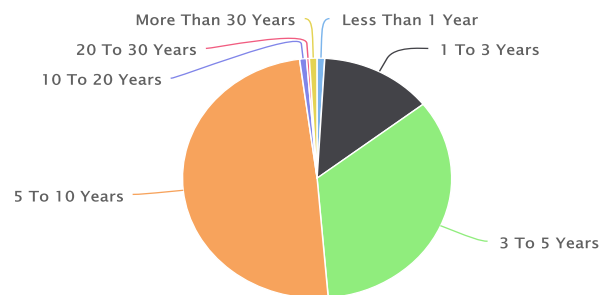

Credit quality ratings on underlying securities of the fund are provided by S&P, Moody's and Fitch.
