## The Features

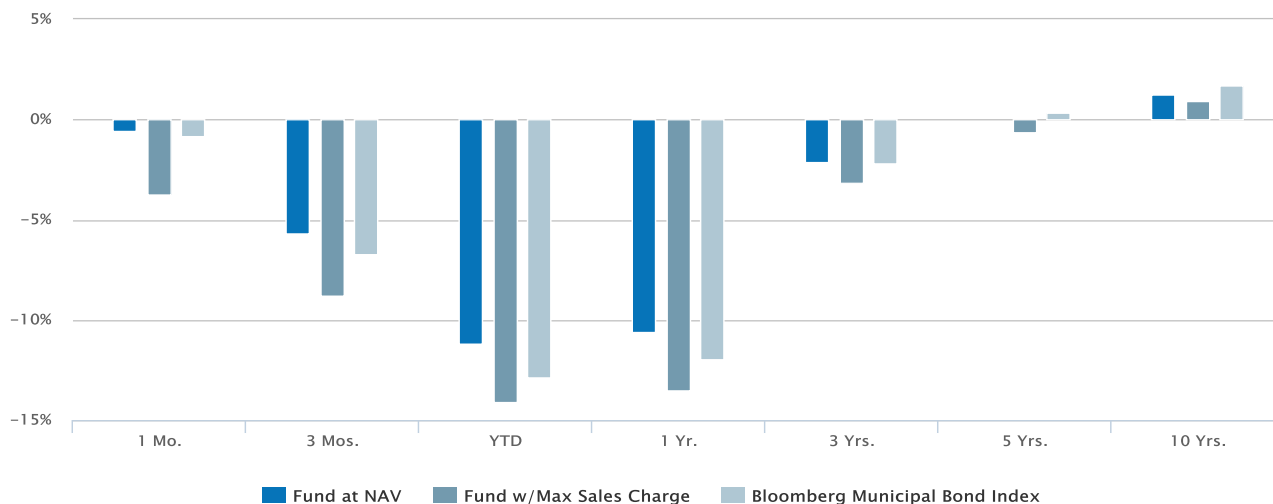
