## The Features

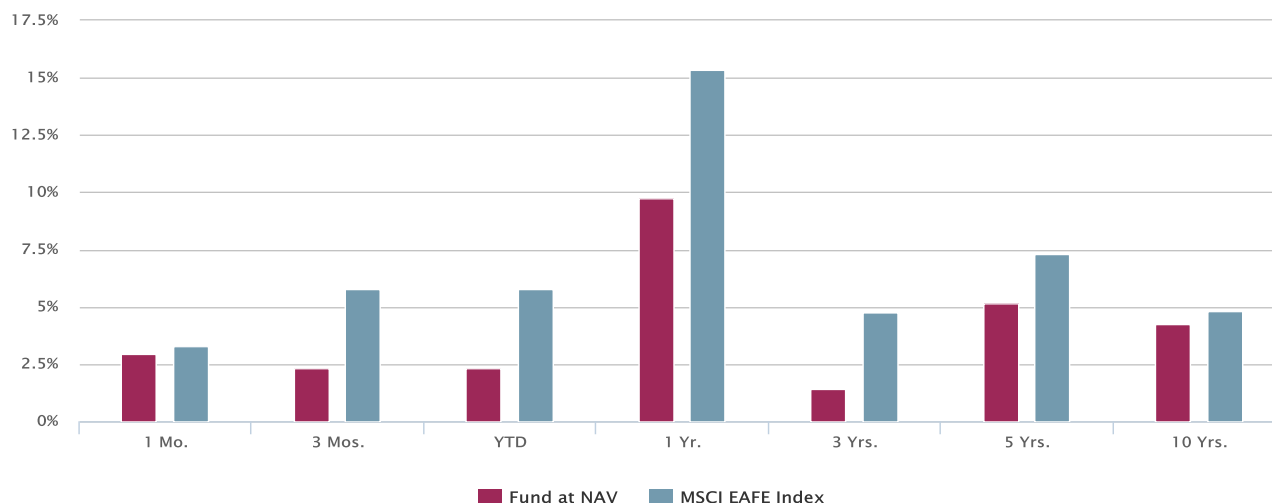

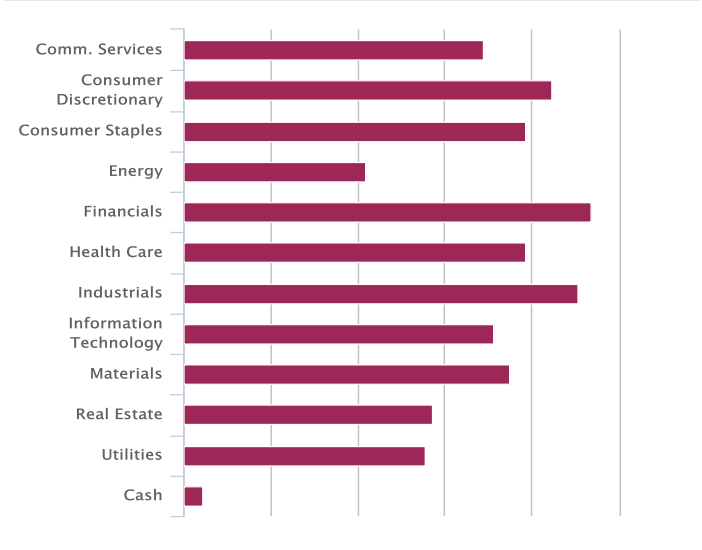

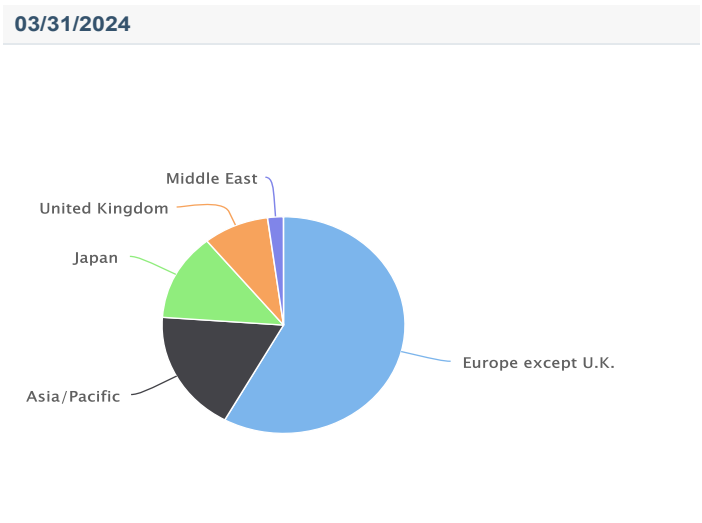
