Access to a broad range of typically unrepresented asset classes, with allocations directed by Fund portfolio managers. The Fund limits its duration to 3.5 years or less.

Broad exposure to a global opportunity set, short duration and an eye toward risk-adjusted performance have helped provide a historically low volatility experience.
