## The Features

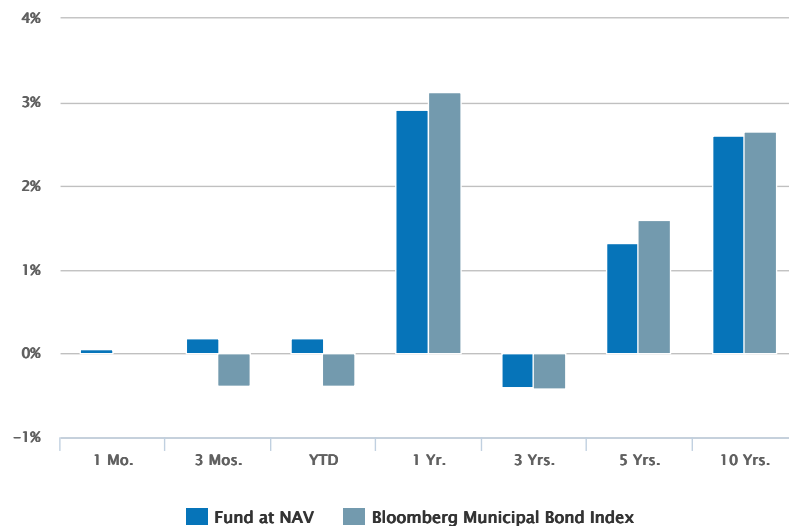

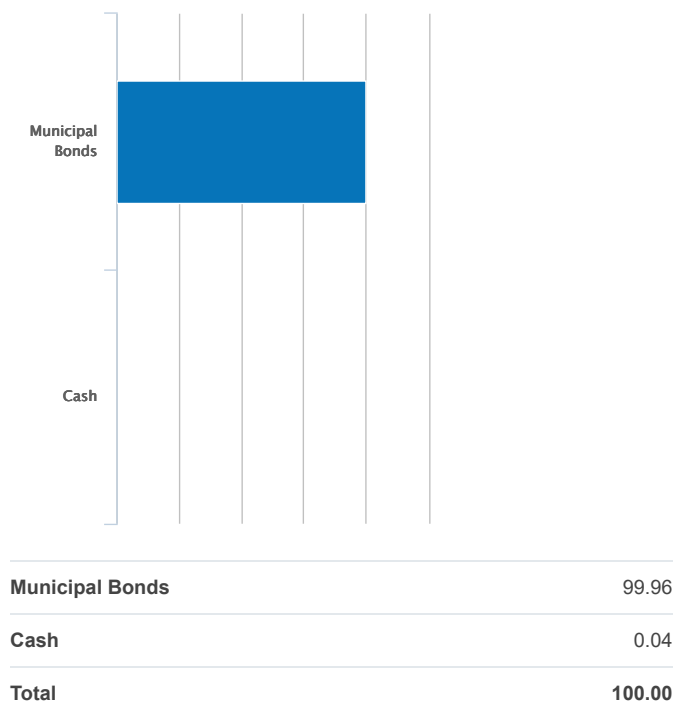

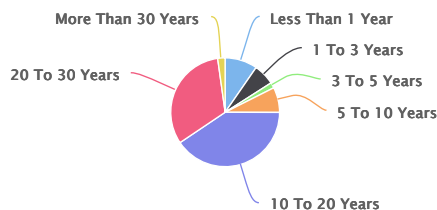
