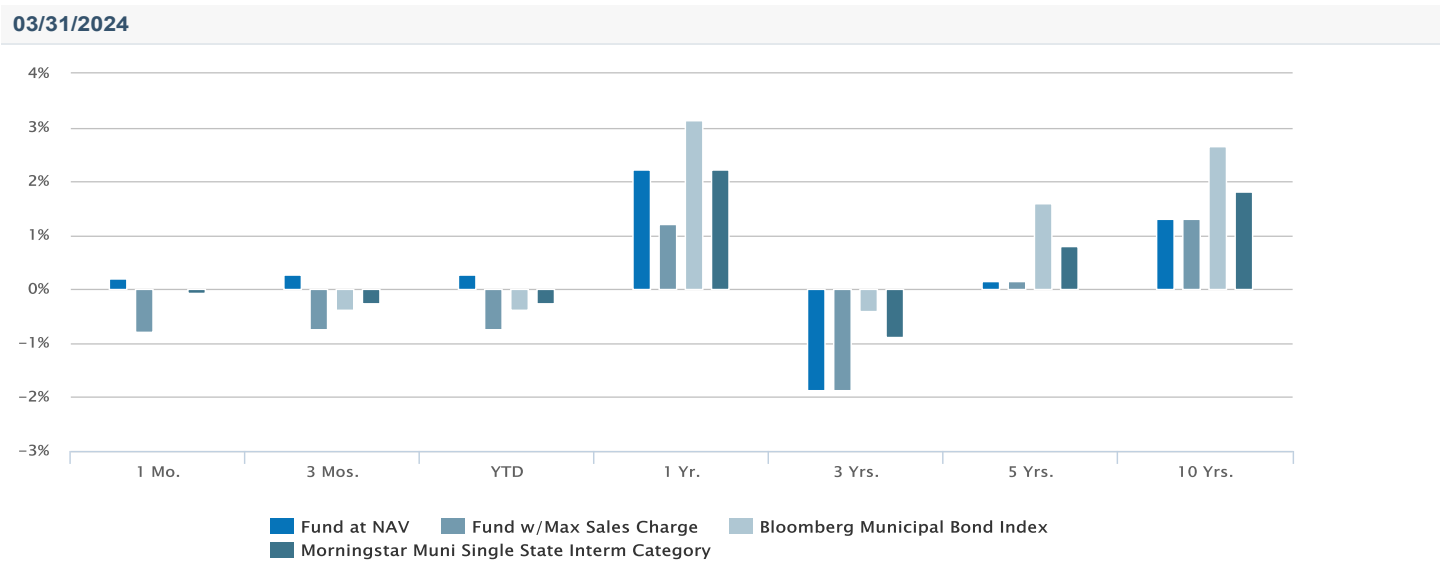

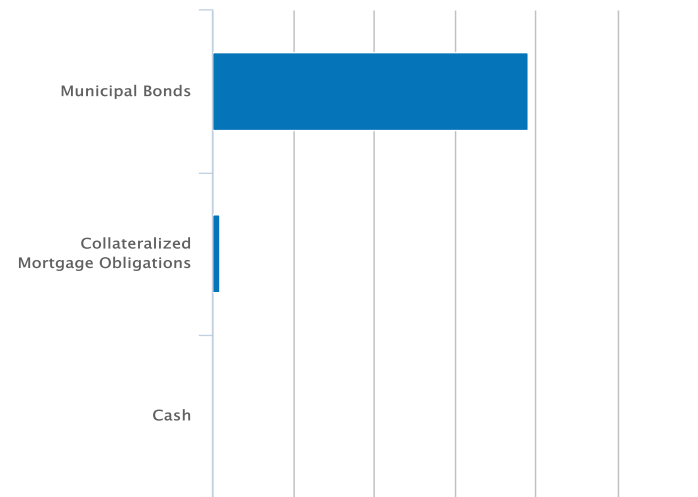

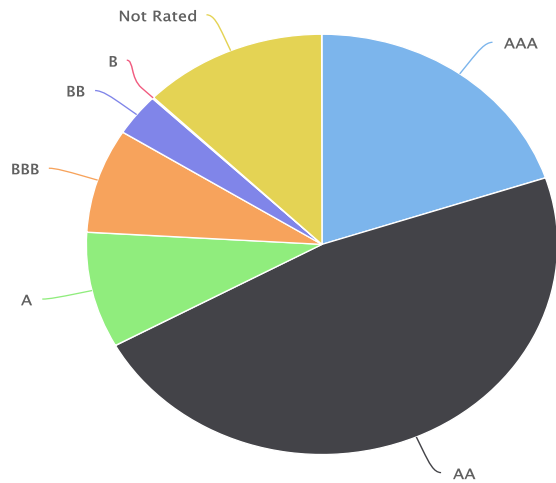

Maturity Distribution (%)¹¹

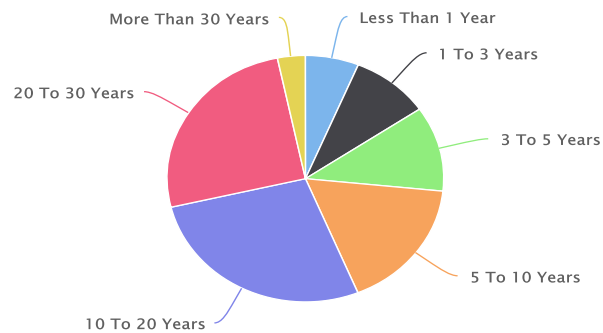
