### Eaton Vance Floating-Rate Income Plus Fund – EFF

As announced on May 14, 2021, Eaton Vance Floating-Rate Income Plus Fund is liquidating. The Fund's last day of secondary trading was on June 18, 2021. The first liquidating distribution was made on June 24, 2021 and represented approximately 95% of the liquidation proceeds or approximately \$15.62 per share. The Fund expects to distribute the remaining proceeds by October 2021.
