If you'd like to receive your tax forms via electronic delivery instead of by mail, please log into your account and enroll in E-Delivery. You will be notified by e-mail once your tax form(s) are ready to be downloaded.

Retirement Forms (1099-R)	Will be mailed by January 31, 2022.
Non retirement Forms (1099-DIV, 1099-B)	Will be mailed by February 15, 2022.
Real Estate Fund shareholders (1099-DIV, 1099-B)	Will be mailed by March 15, 2022.
Holders of both retirement and non-retirement accounts	Will receive forms in separate packages.
Accounts with less than \$10.00 of reportable income	May not receive a tax form.
Tax forms for closed-end funds	Are issued by your brokerage firm. If you have any questions with regard to your closed-end fund tax form, please contact your financial advisor.
