#### **The Fund**

This offering provides exposure to the municipal bond market, seeking to provide Fund shareholders with current income exempt from regular federal income tax. Fund investments span municipal sectors, states and credit tiers, with allocations directed by veteran manager, Cynthia Clemson, since 2005.

The Fund's active management draws upon the expertise of Eaton Vance's municipal bond team, among America's largest and most experienced municipal bond managers. The investment team applies Eaton Vance's credit research process, while implementing a relativevalue trading approach to municipal investing.

#### The Features






# Credit Quality (%)<sup>11</sup>
