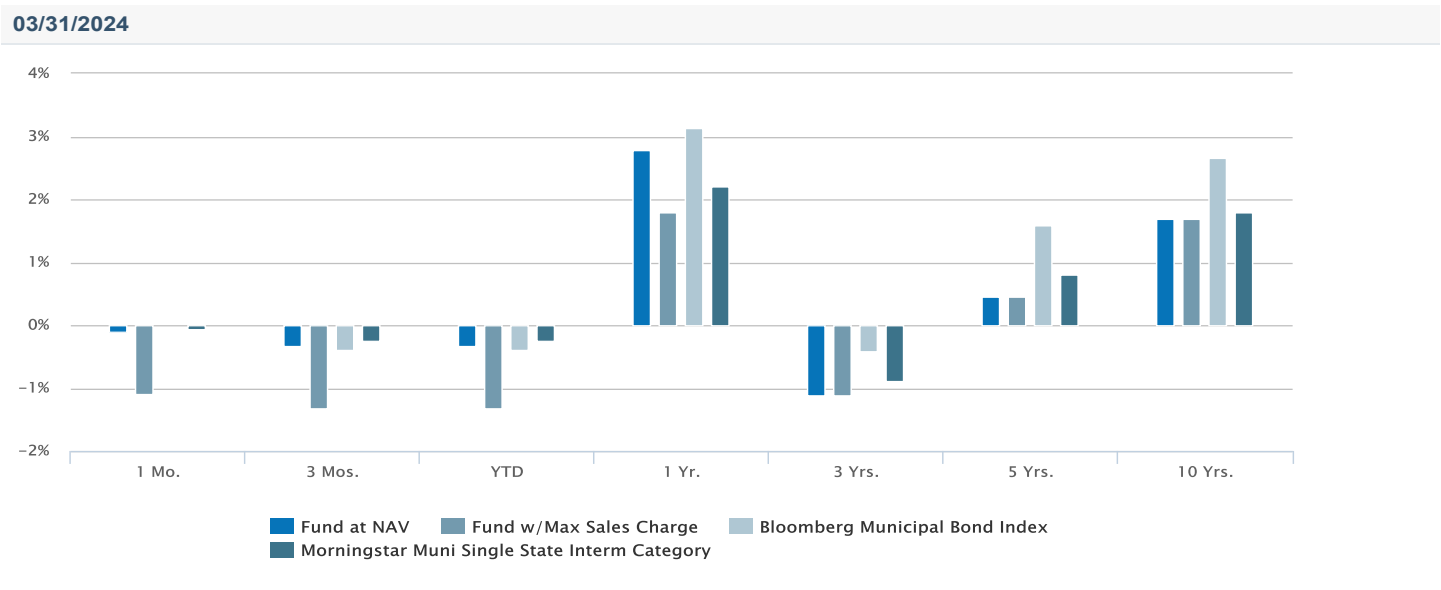

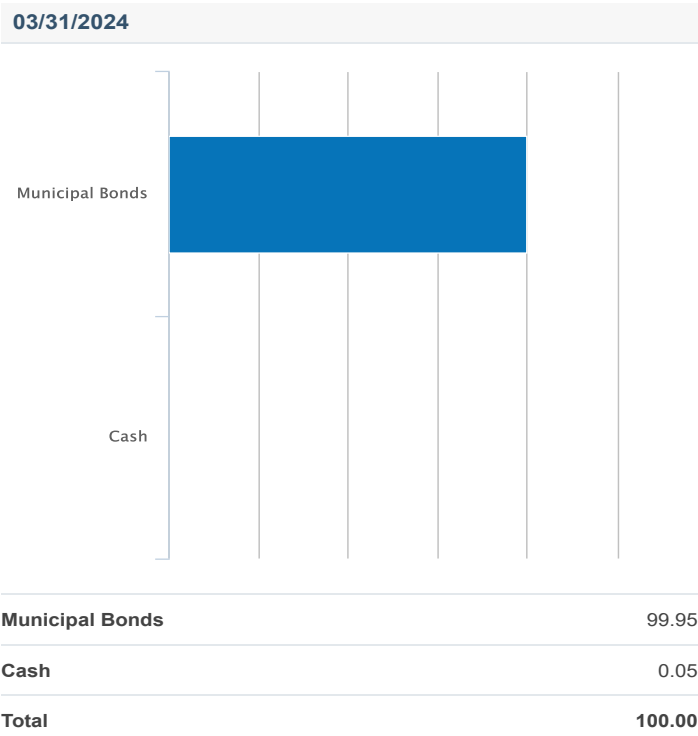

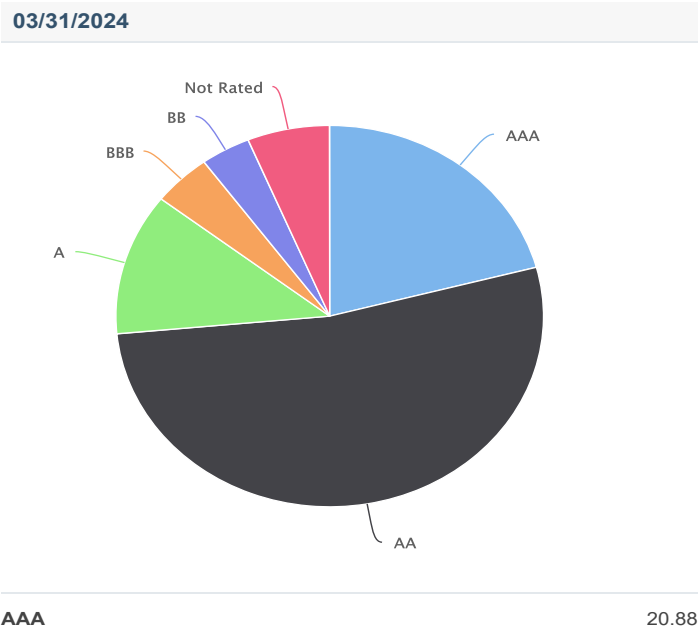

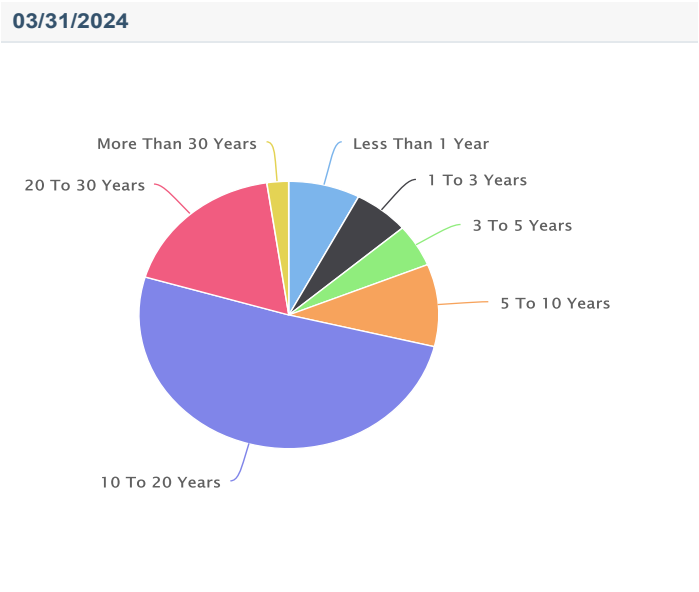
Credit Quality (%)<sup>12</sup>
