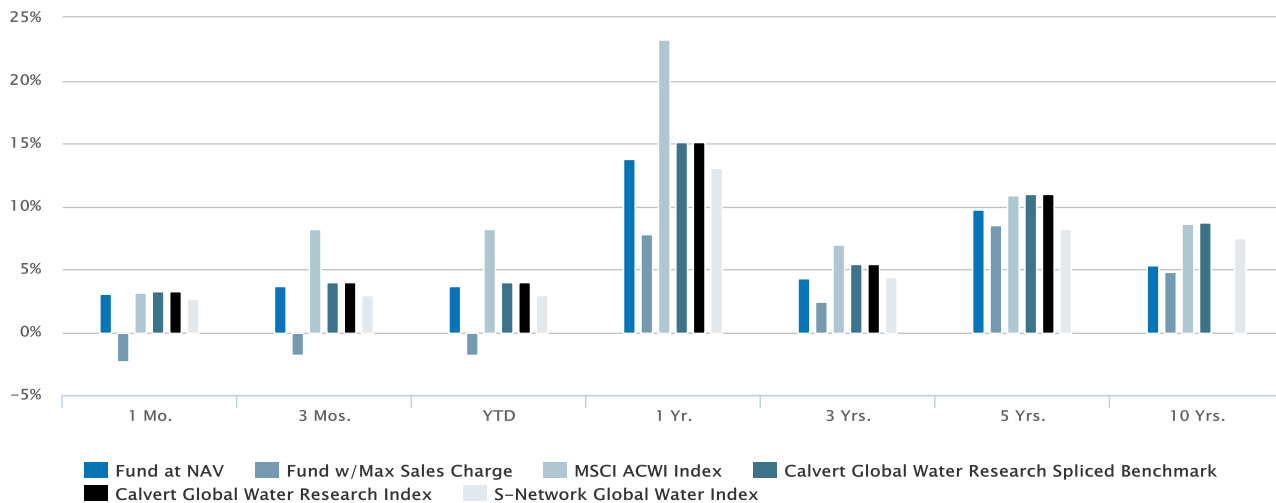

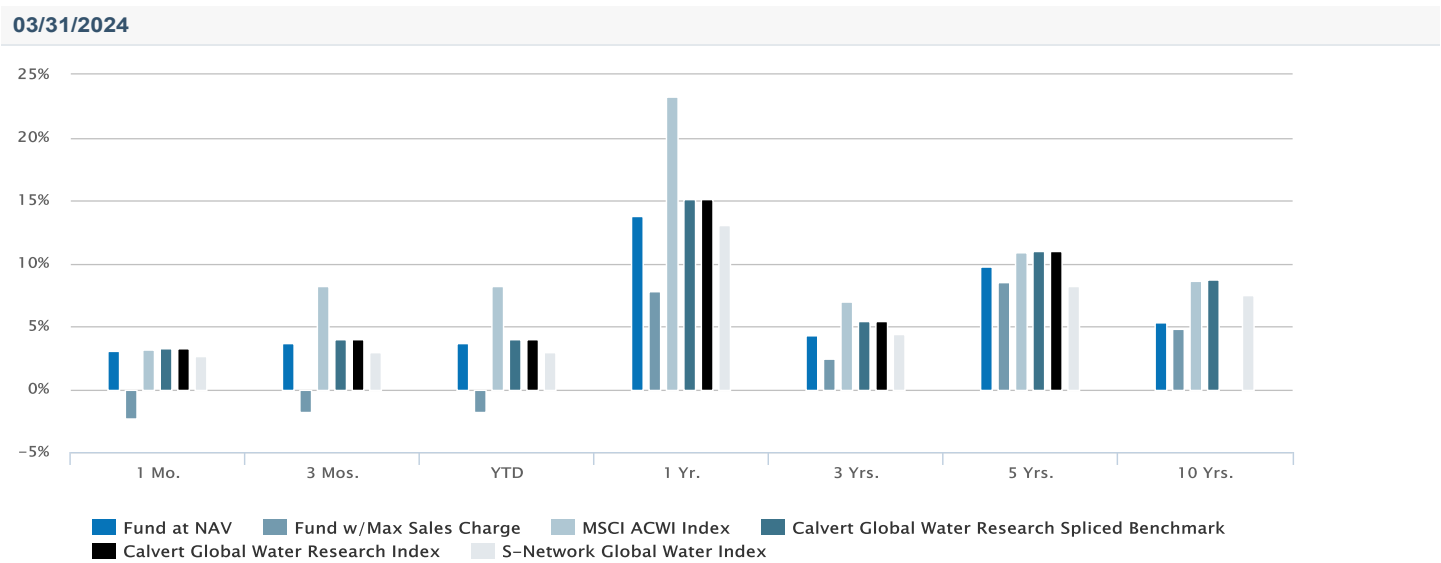

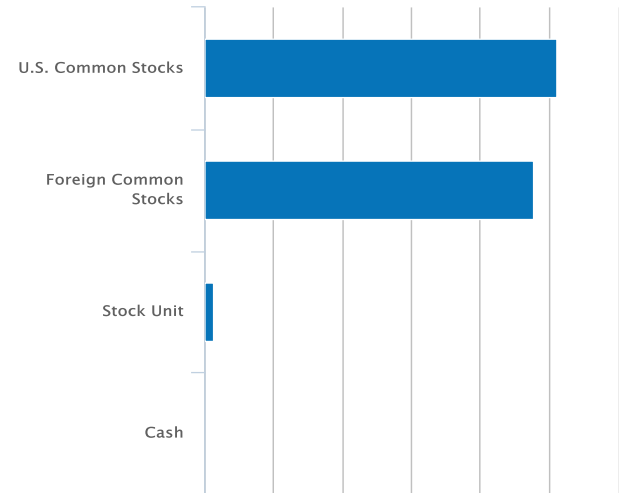
### Asset Mix (%)<sup>8</sup>

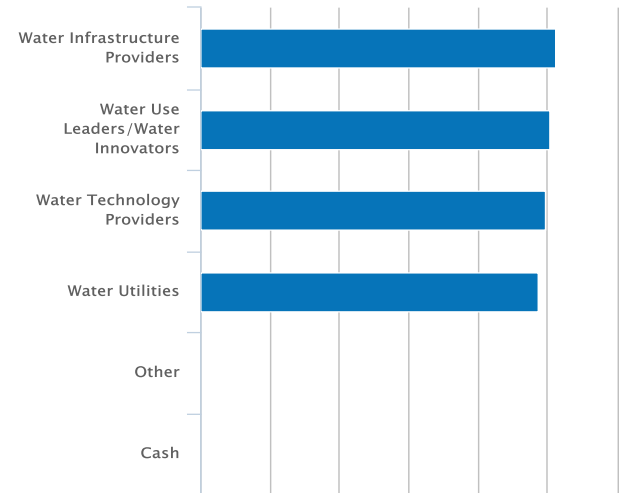

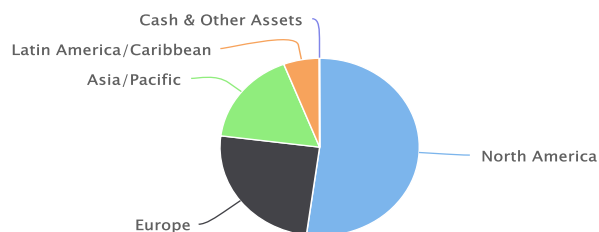
