## The Features

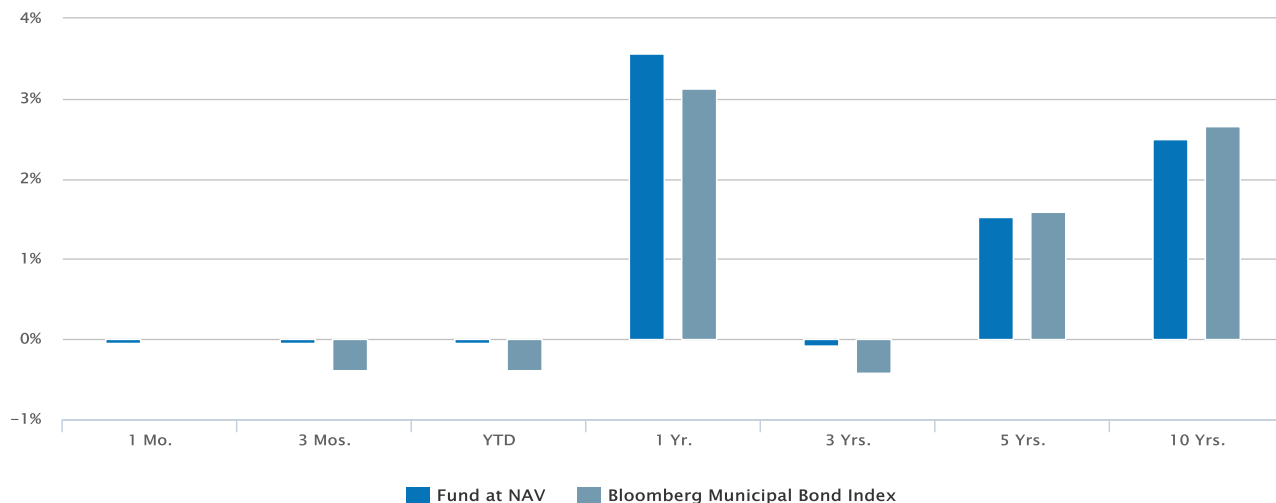

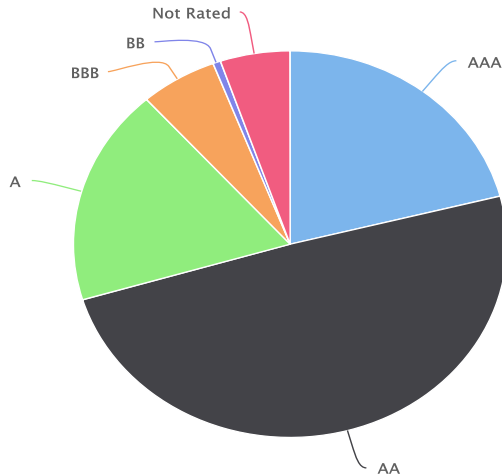

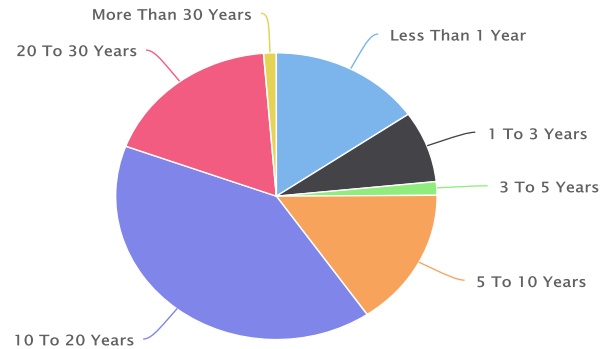
