## The Features

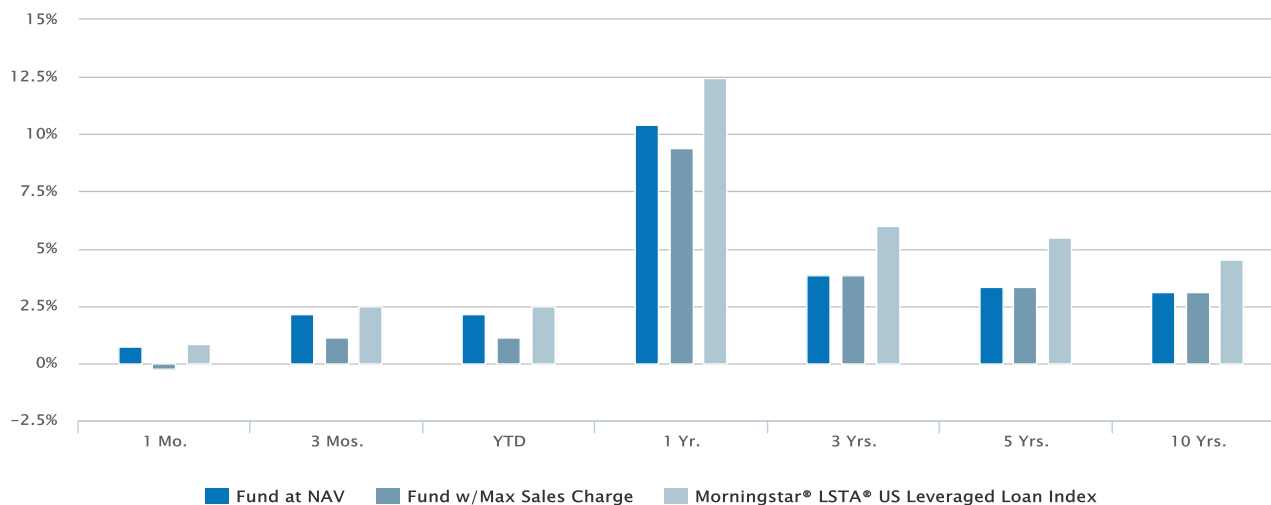

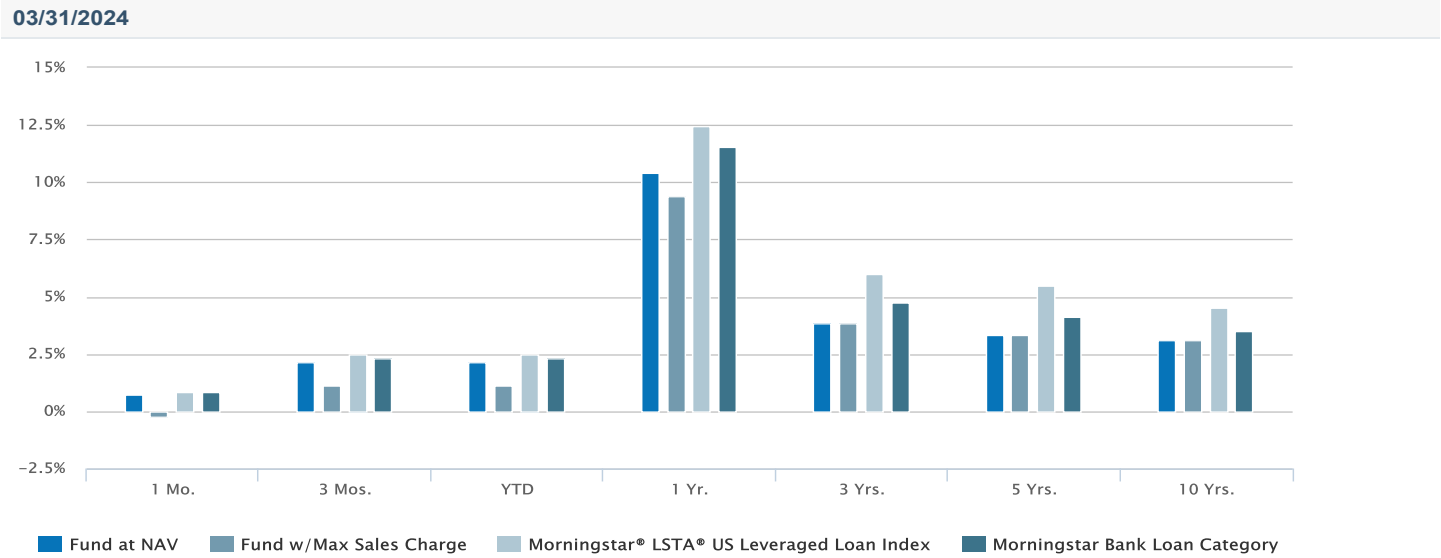

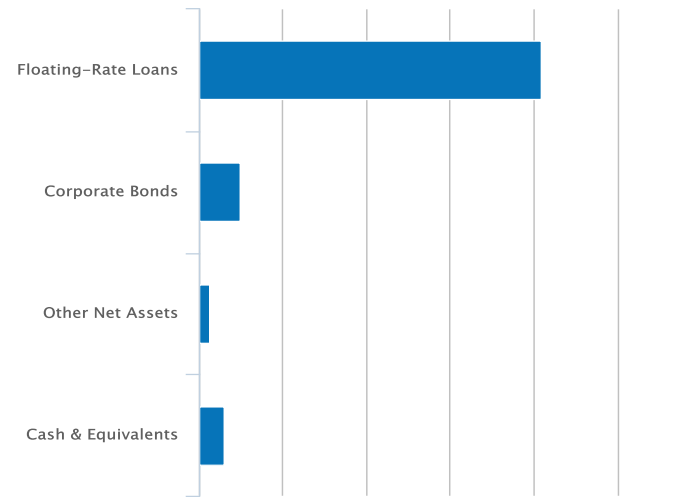

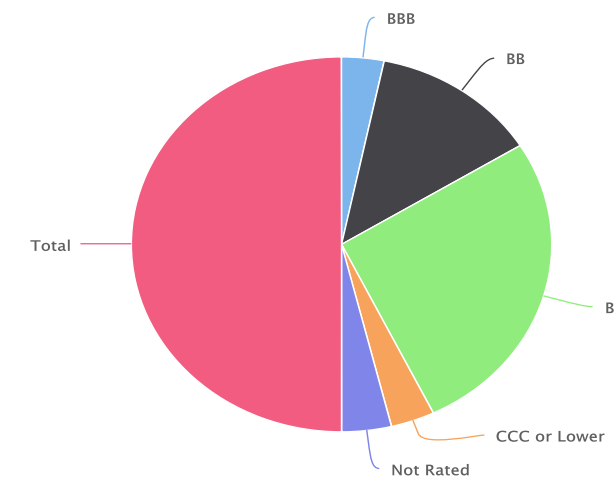

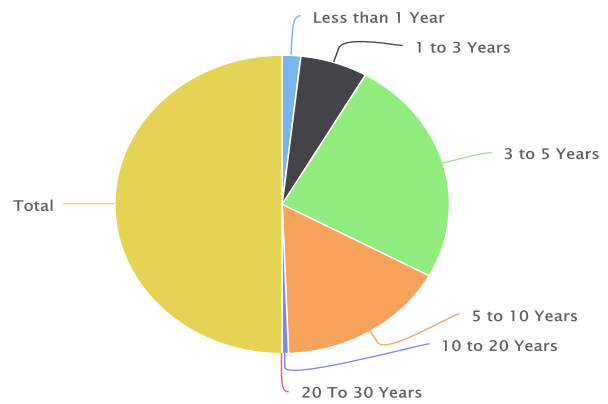
