### The Fund

Managed by Eaton Vance, a pioneer in floating-rate loans since 1989, this portfolio diversifier provides broad exposure to the floating-rate loan market. In-depth, bottom-up credit research and broad diversification<sup>1</sup> are this Fund's cornerstones, managed by one of America's largest and most experienced loan managers.

# The Approach

Invests broadly across the floating-rate loan market, providing diversified exposure to the asset class. Provides exposure to the loan market's many sectors, credit tiers and issuers. A focus on research and diversification may help provide lower volatility than the overall market, while seeking to contain risk in difficult environments.






