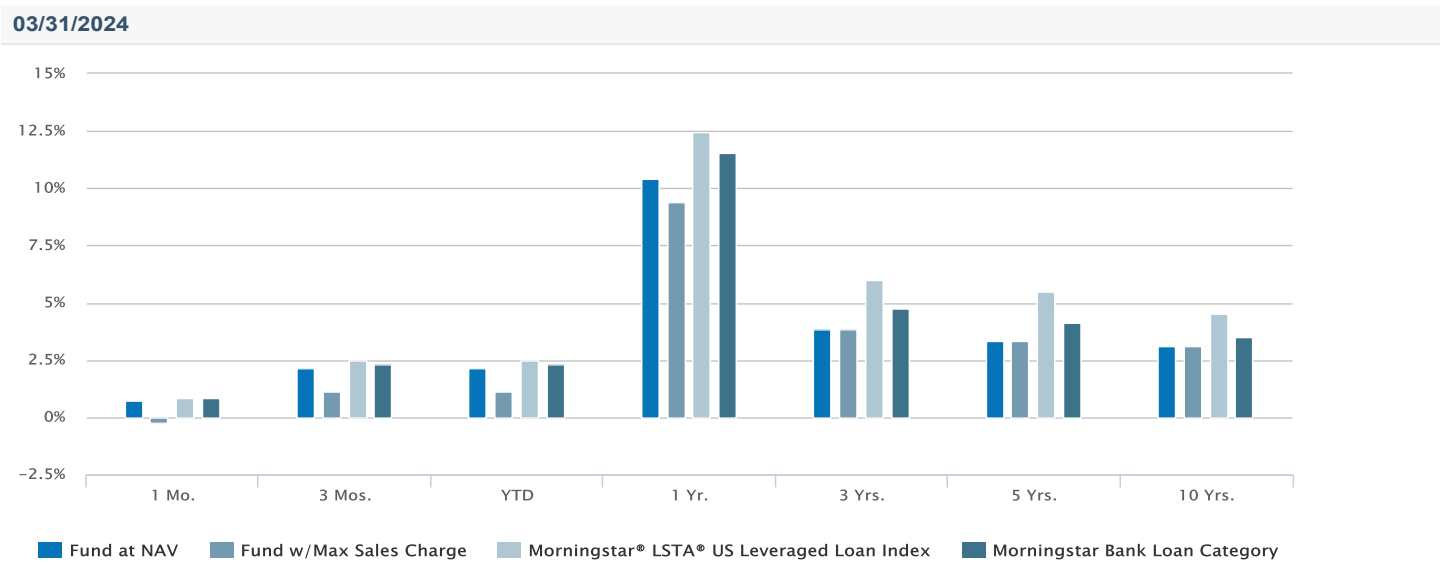

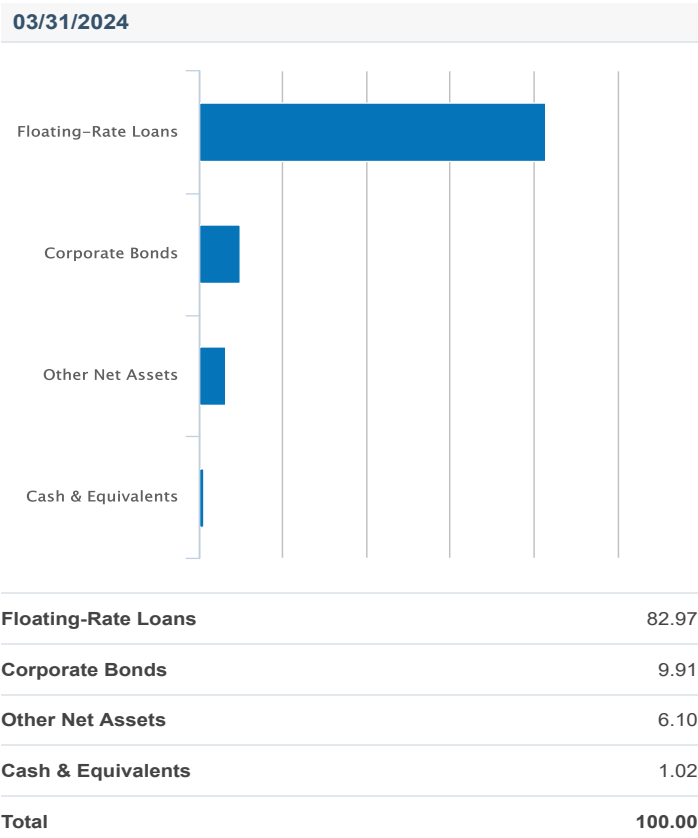

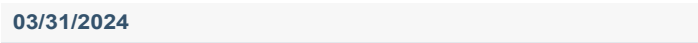

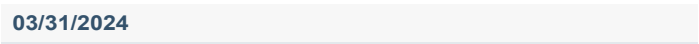
Credit Quality (%)⁸

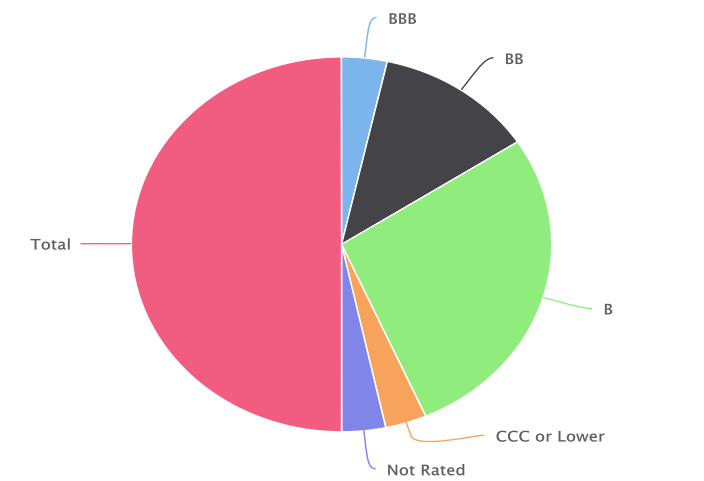

Maturity Distribution (%)^{4,9}

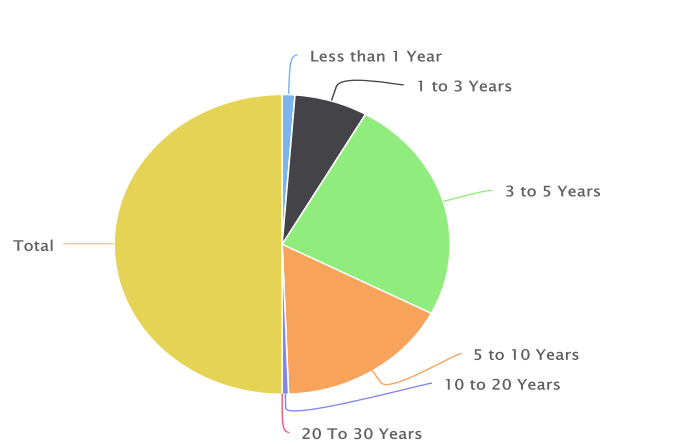
