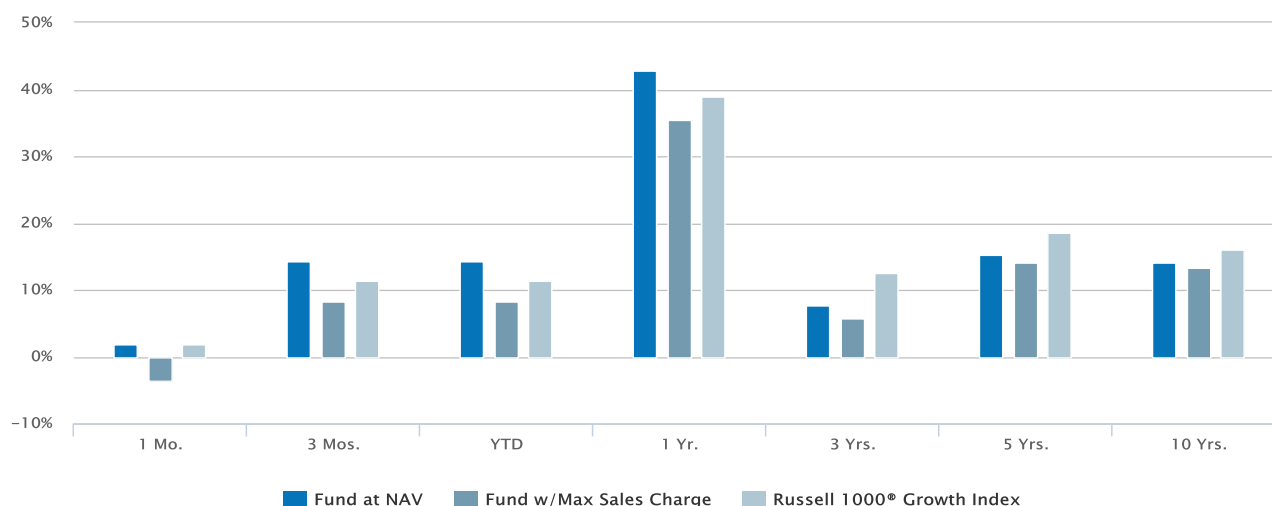
The Features

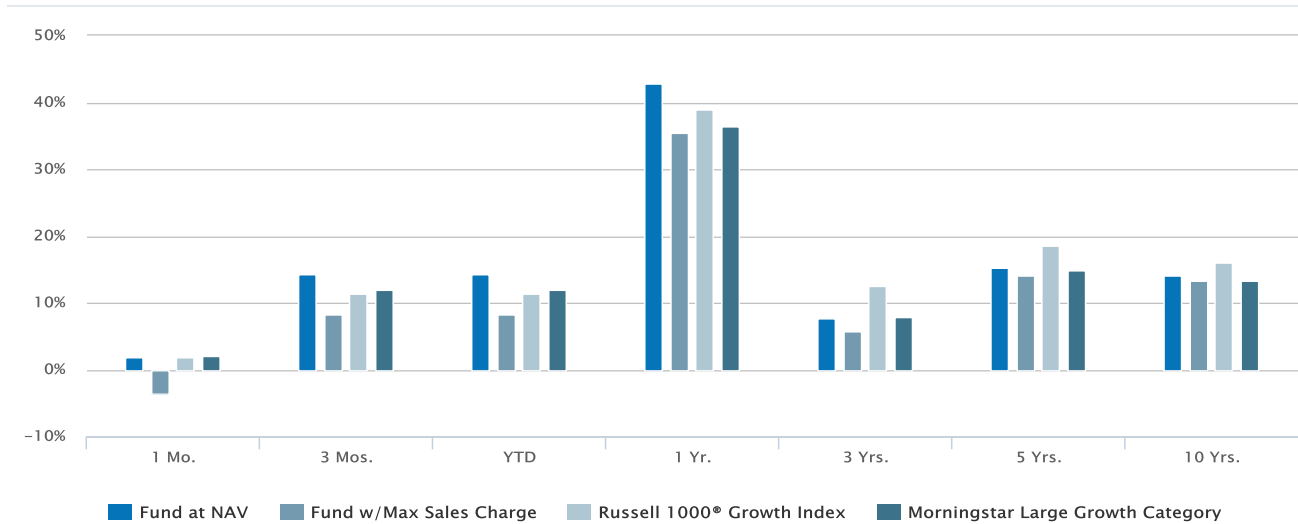

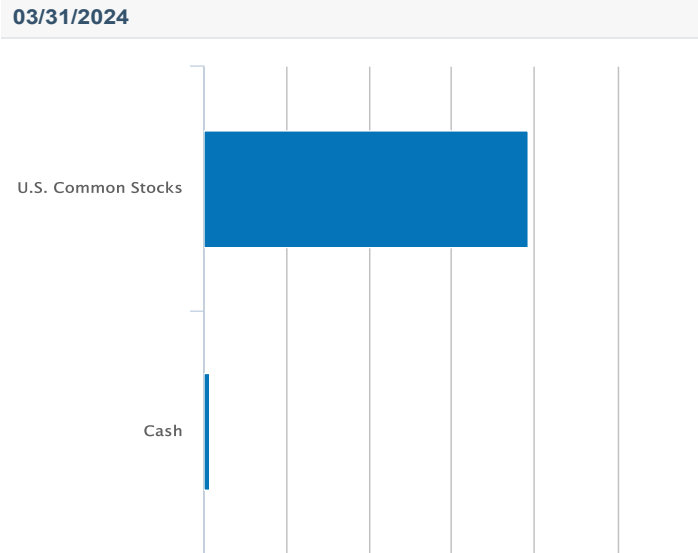
