## The Features

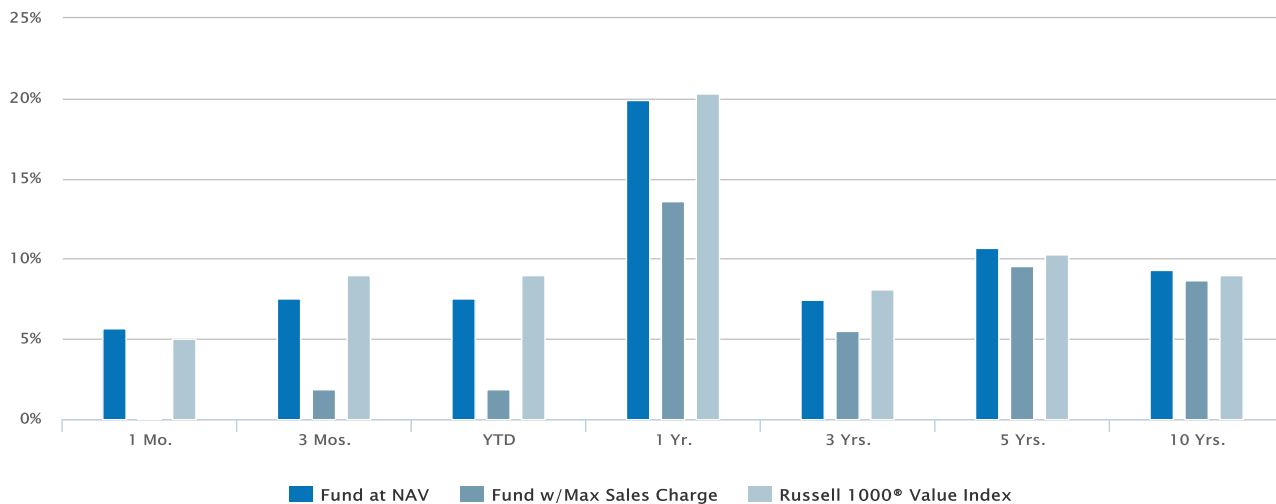

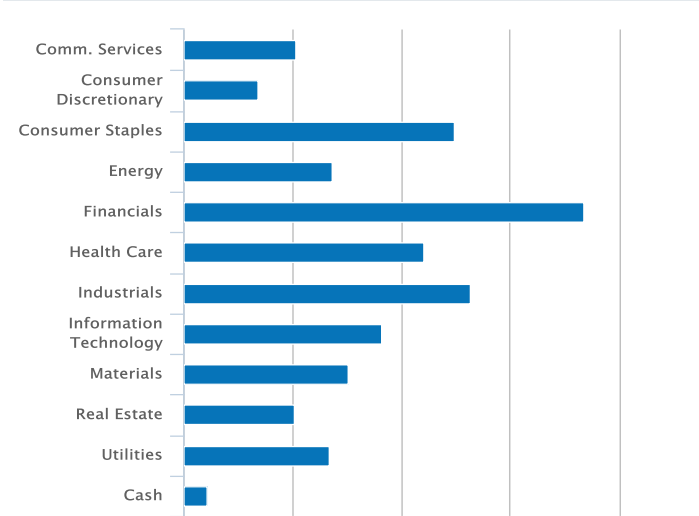
