## The Features

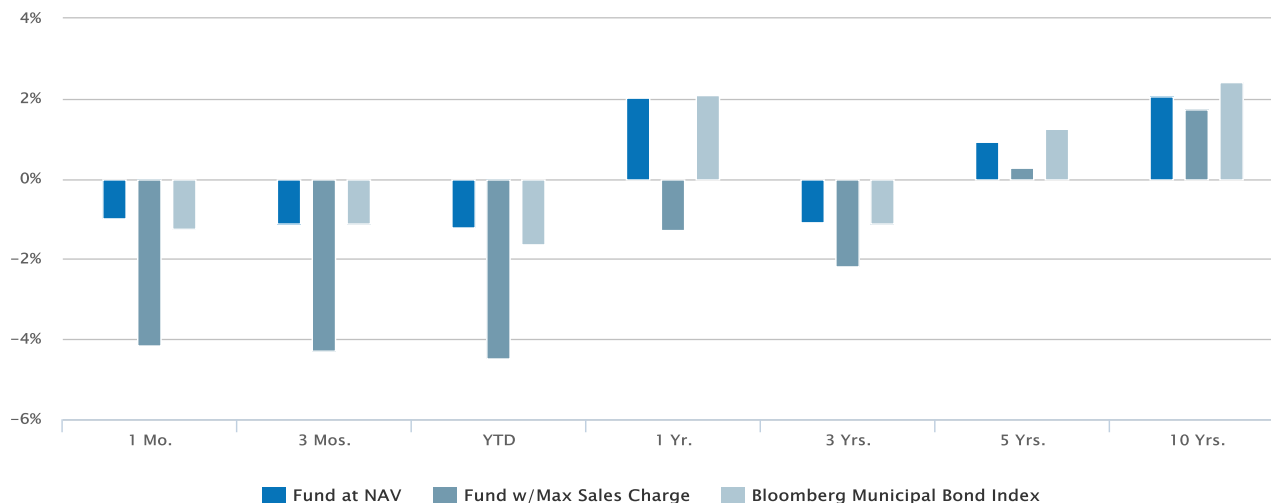

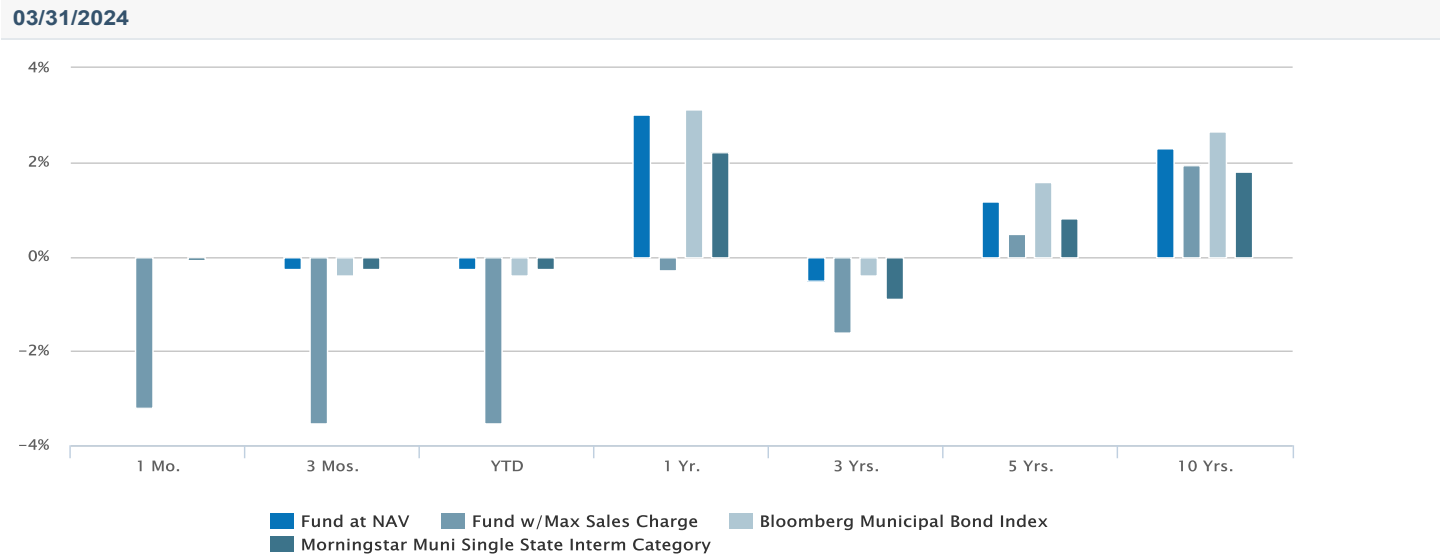

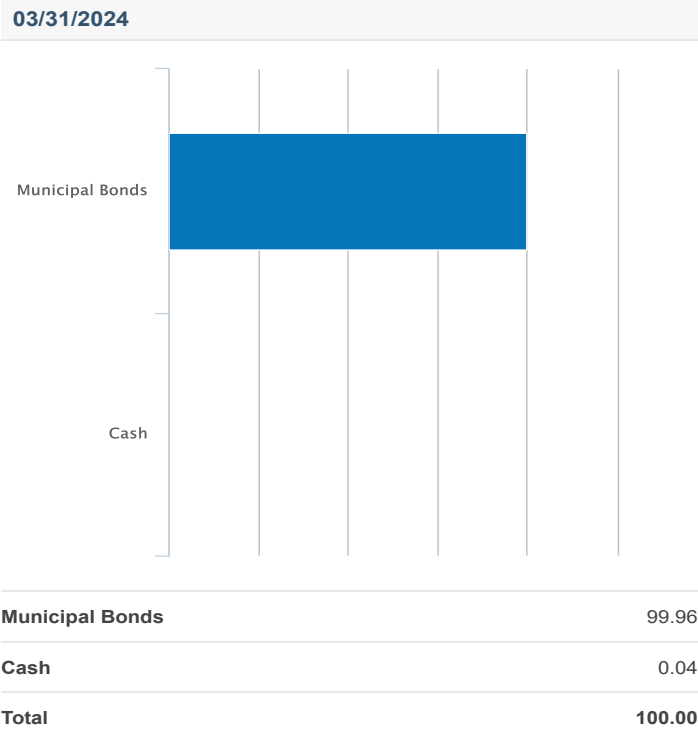

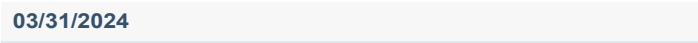

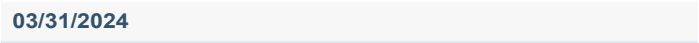

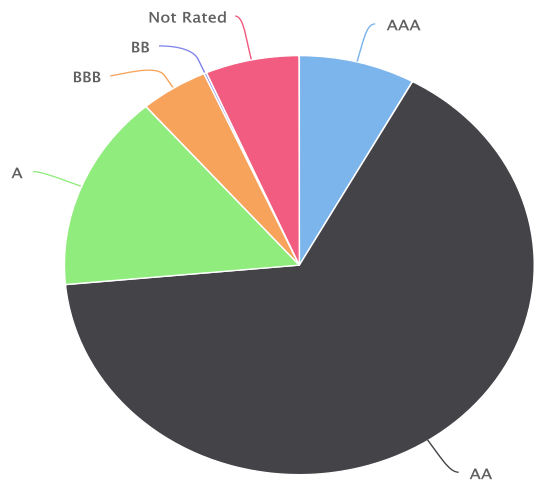

Maturity Distribution (%)<sup>11</sup>

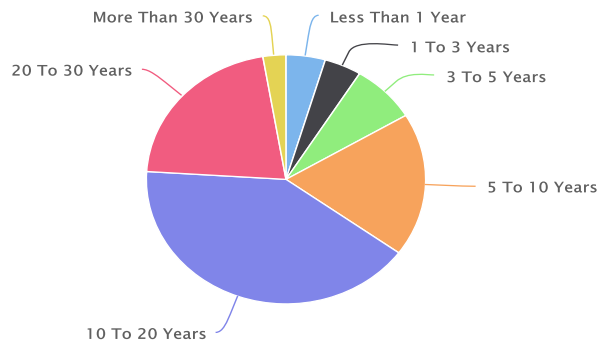
