## The Features

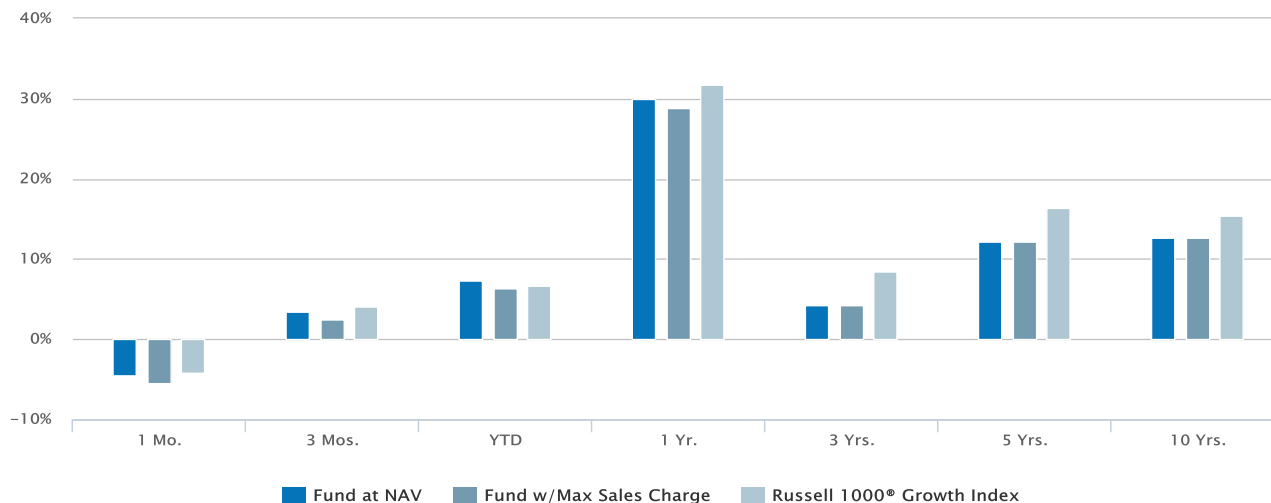

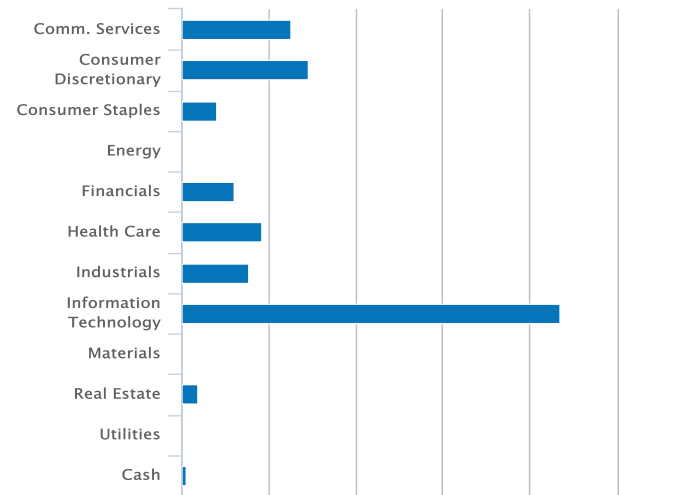
