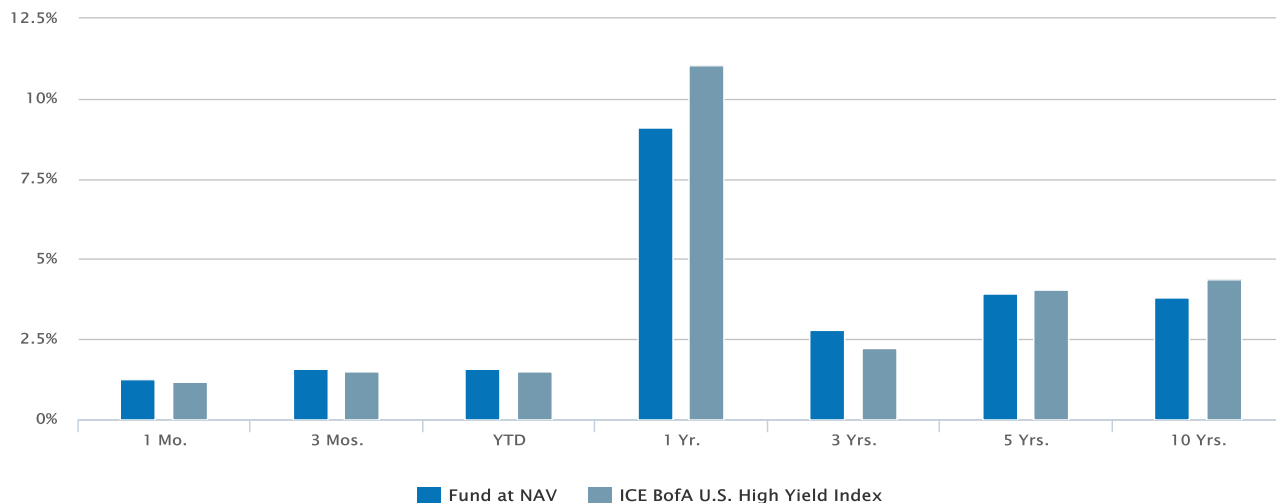

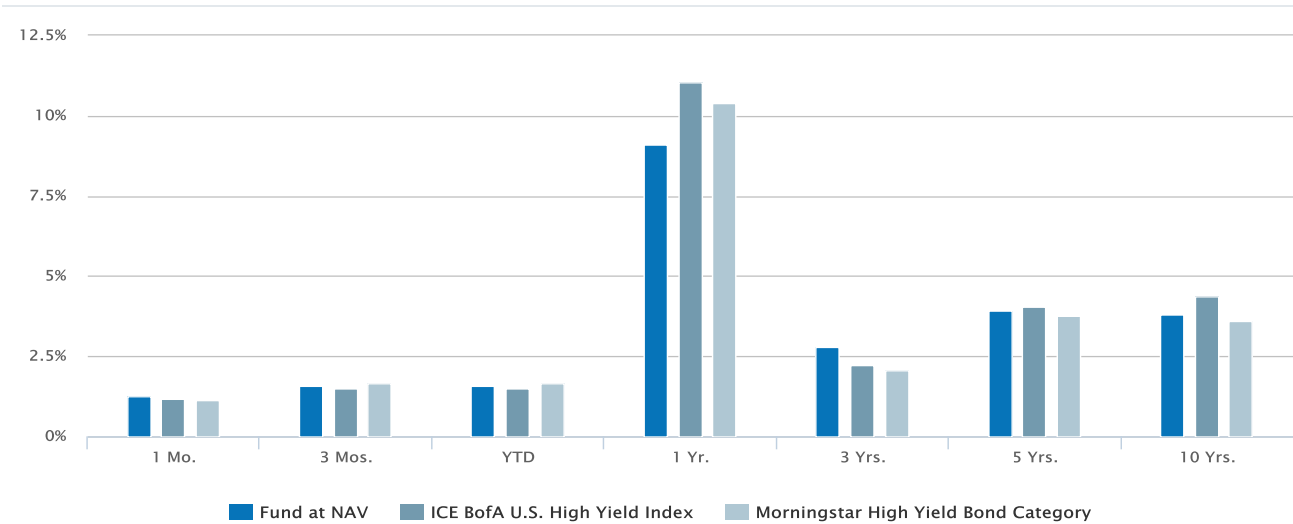

Asset Mix (%)⁴

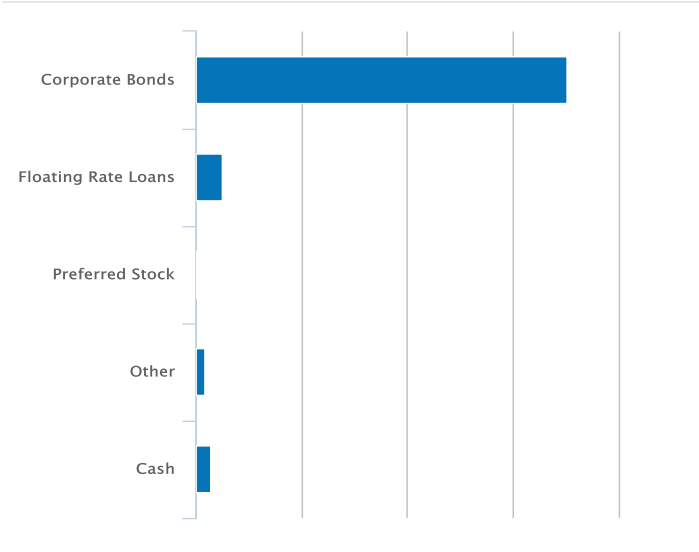

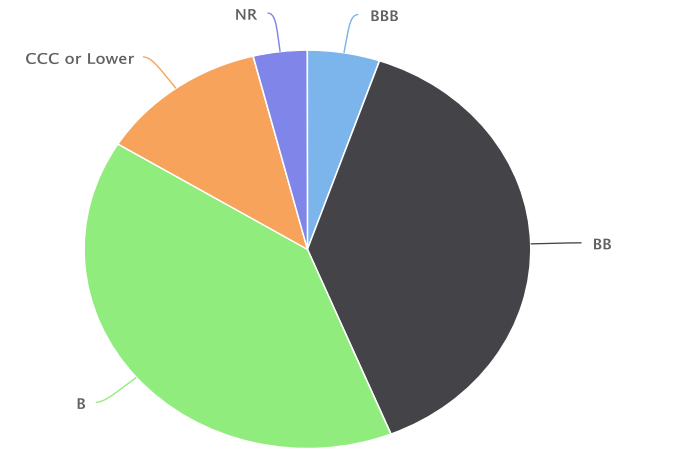

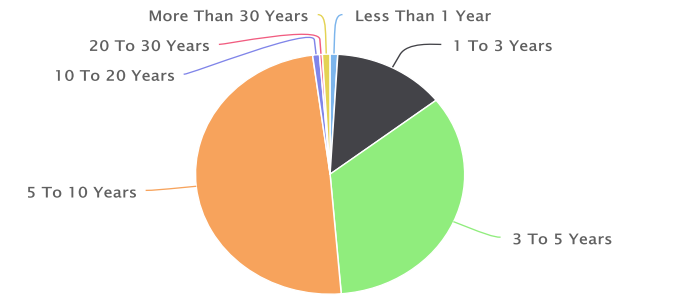

Credit quality ratings on underlying securities of the fund are provided by S&P, Moody's and Fitch.
