## The Features

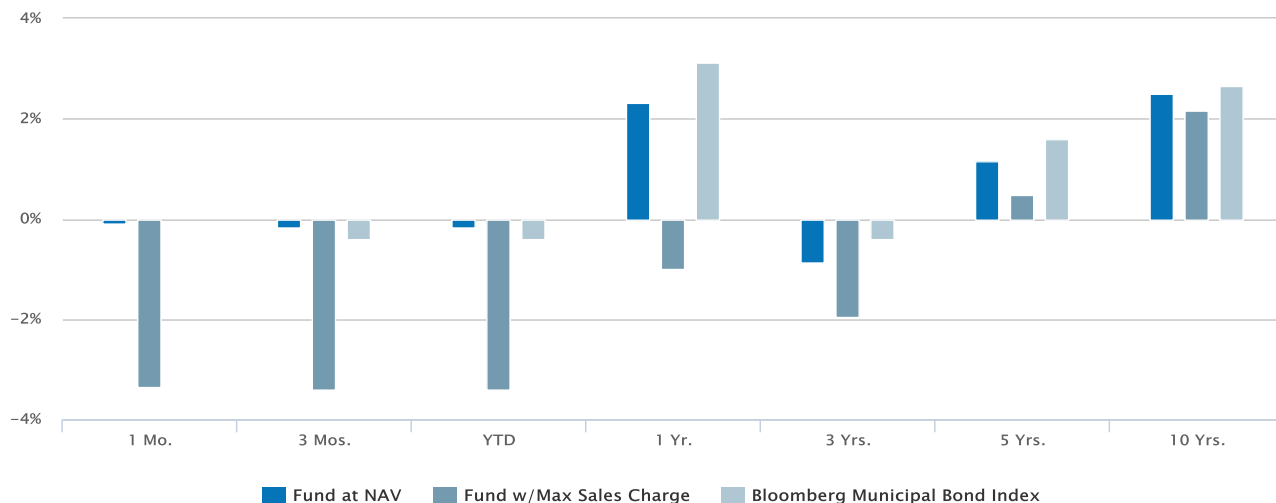

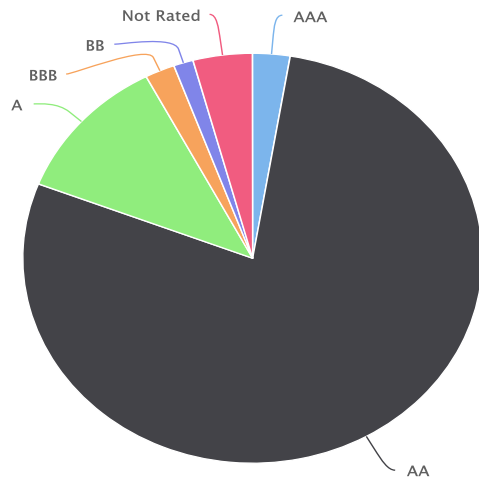

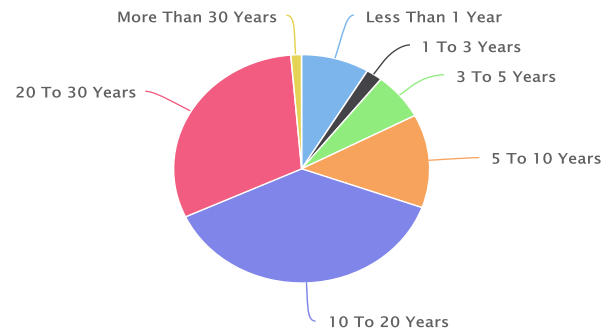
