## The Fund

The Fund's rules-based, top-down process seeks to take advantage of certain quantitative and behavioral characteristics of the commodity markets.

## The Approach

The Fund offers a broad-based commodity exposure across 32 commodities that make up the index. This is delivered through a system of target weights and rebalancing bands, which systematically rebalance the portfolio back to these target weights. This disciplined process captures a "rebalancing alpha" <sup>1</sup> independent of any forward looking views.

## The Features

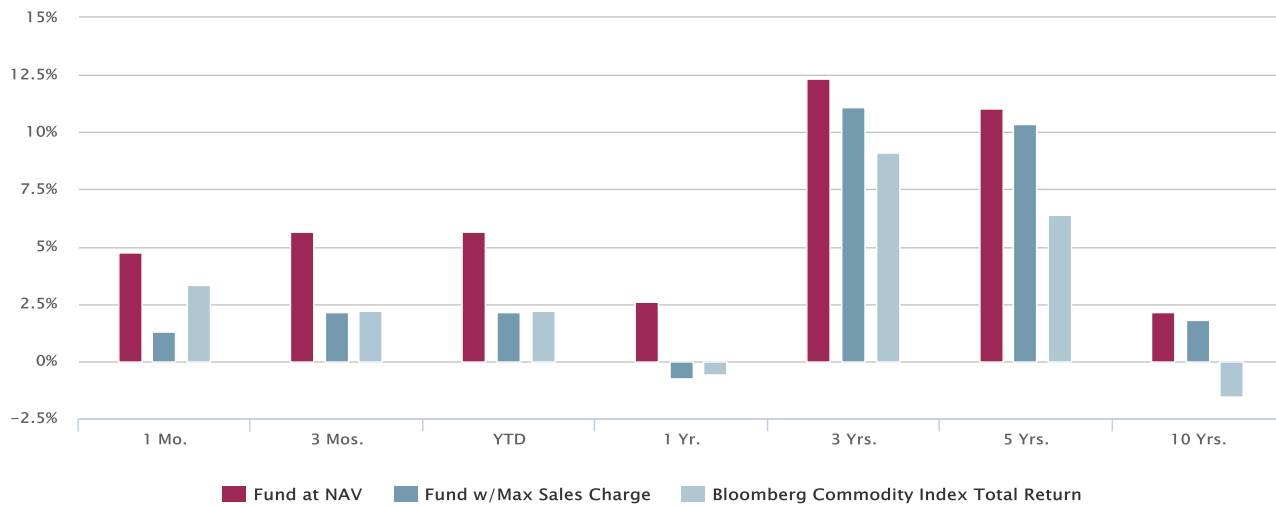
Commodities have historically provided investors with a hedge against inflation, as well as returns that are uncorrelated to more traditional asset classes, such as stocks and bonds.

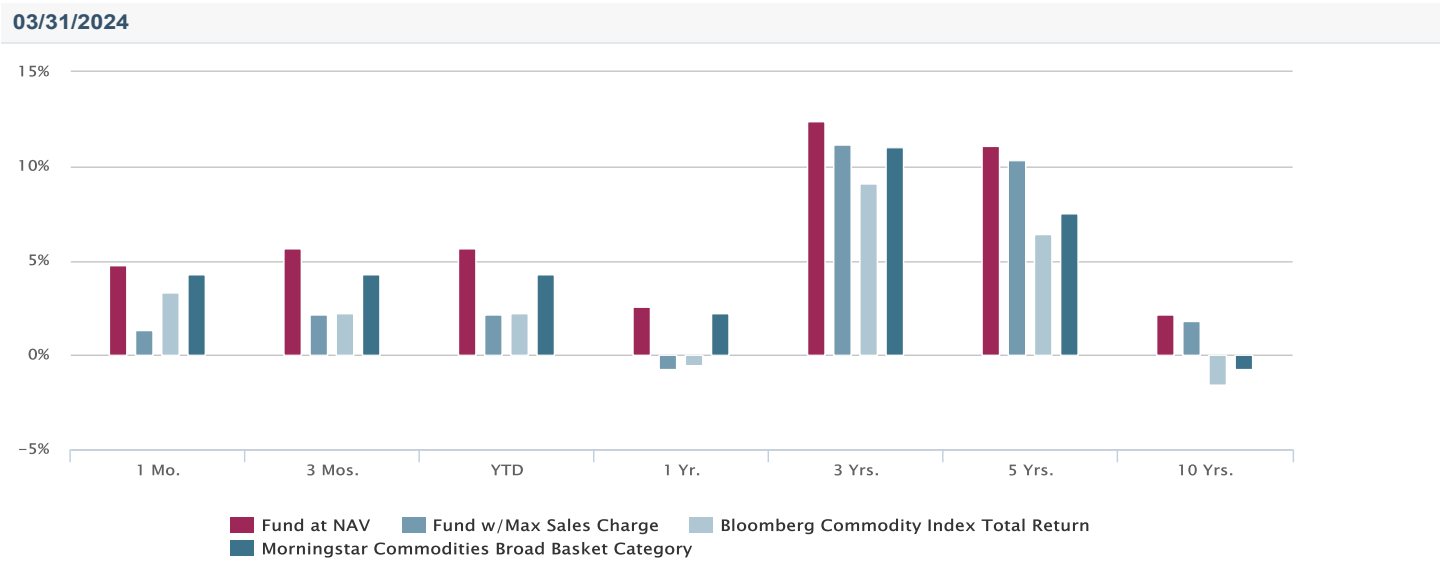
