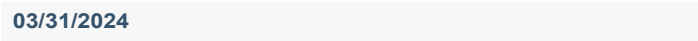

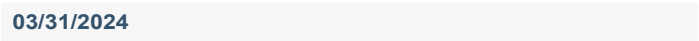
Credit Quality (%)<sup>10</sup>

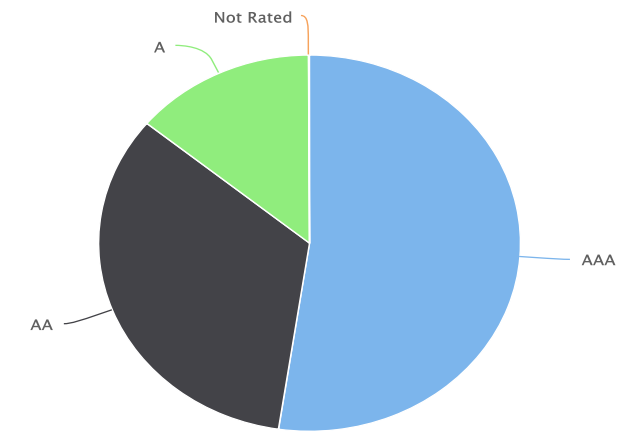

Maturity Distribution (%)<sup>5</sup>

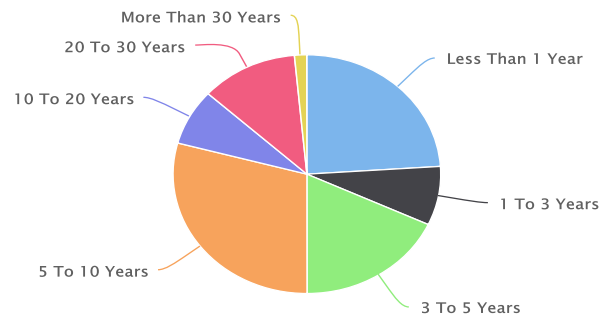

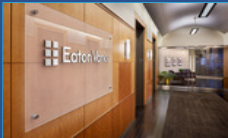
