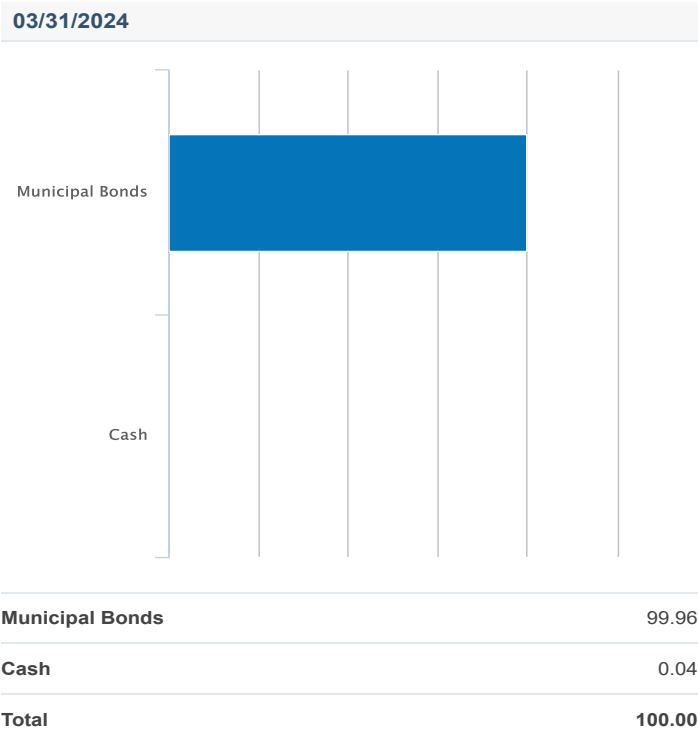

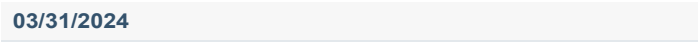

Credit Quality (%)¹⁰

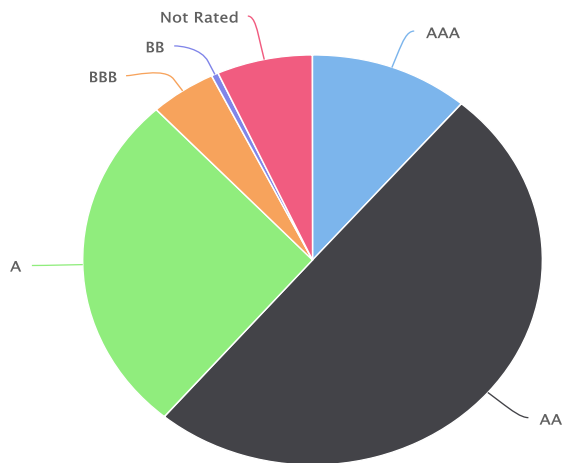

Maturity Distribution (%)¹⁰

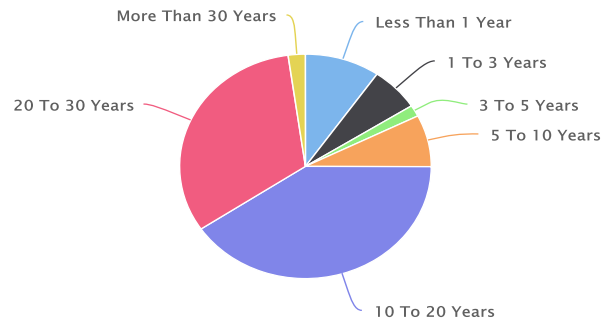
