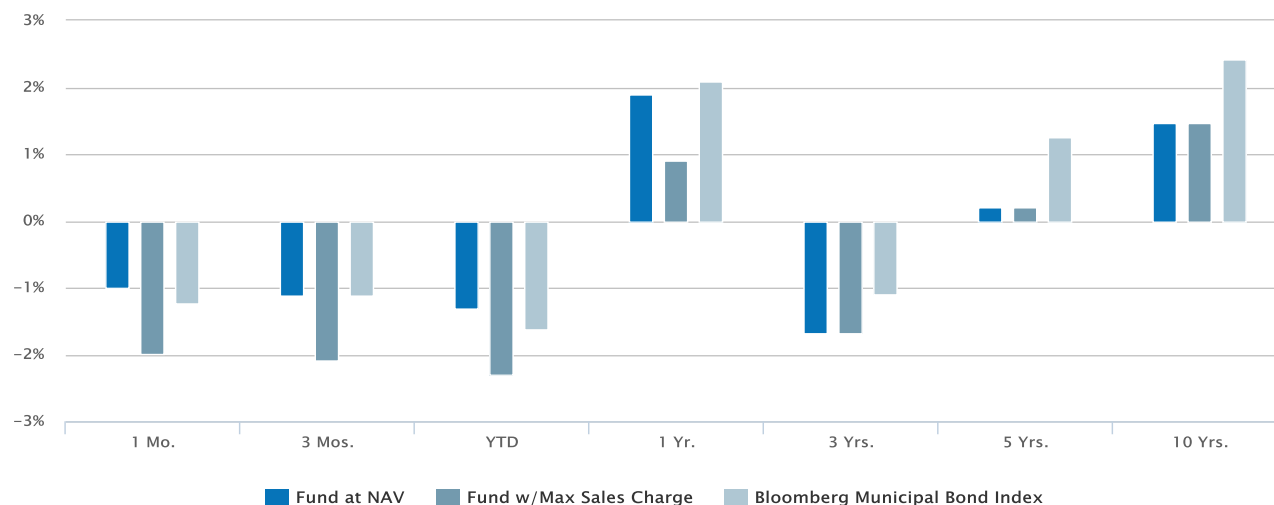

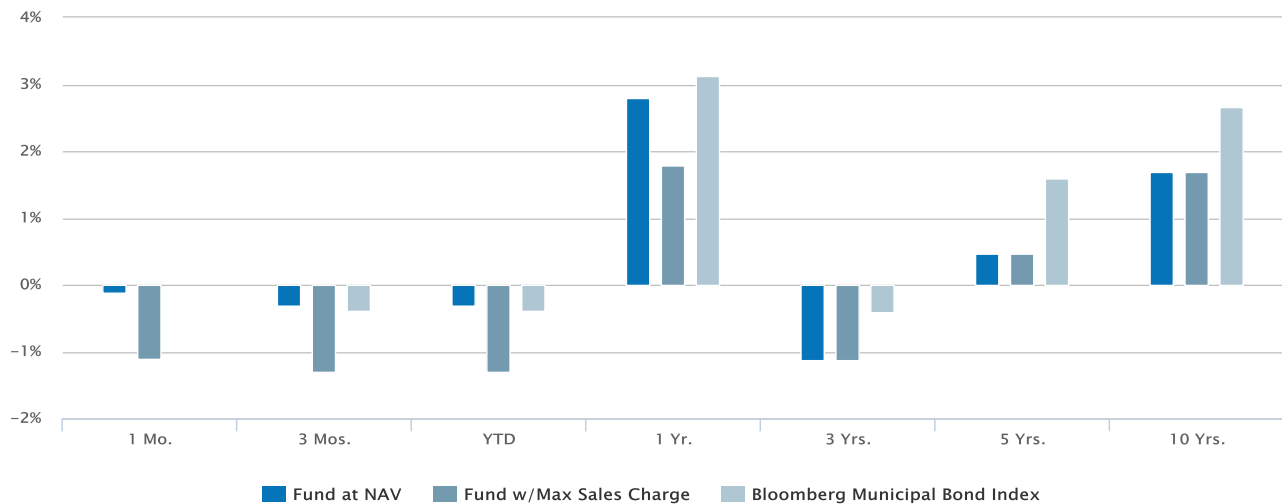

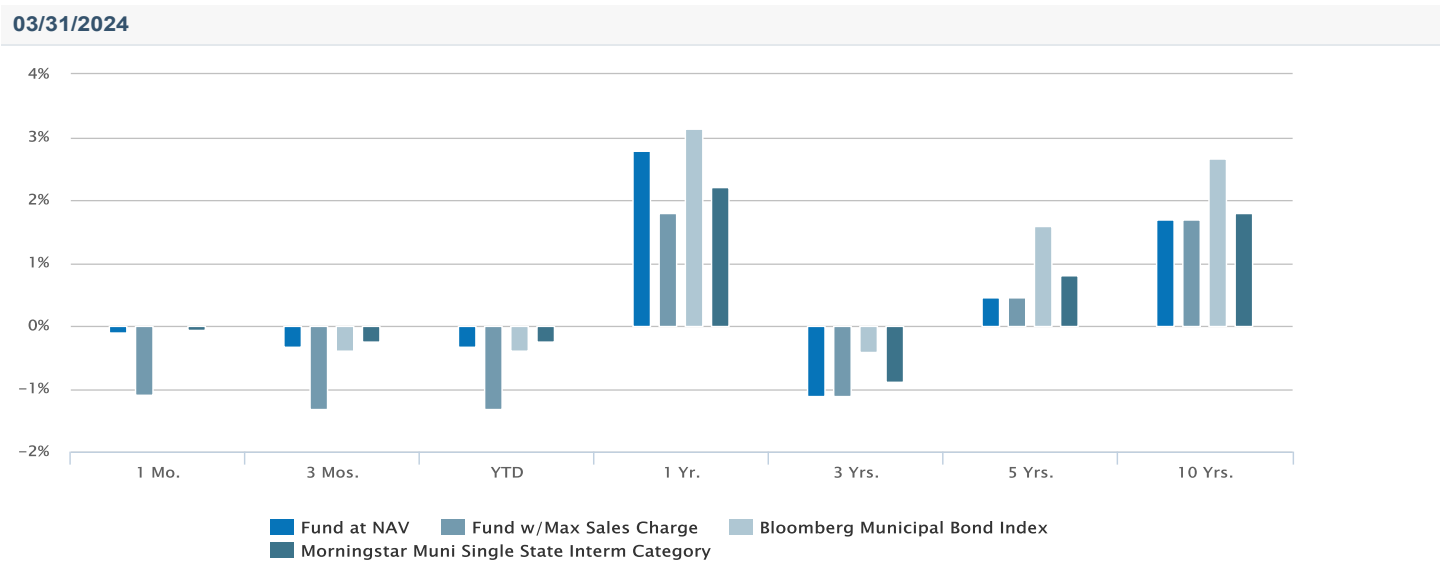

Asset Mix (%)^{3,11}

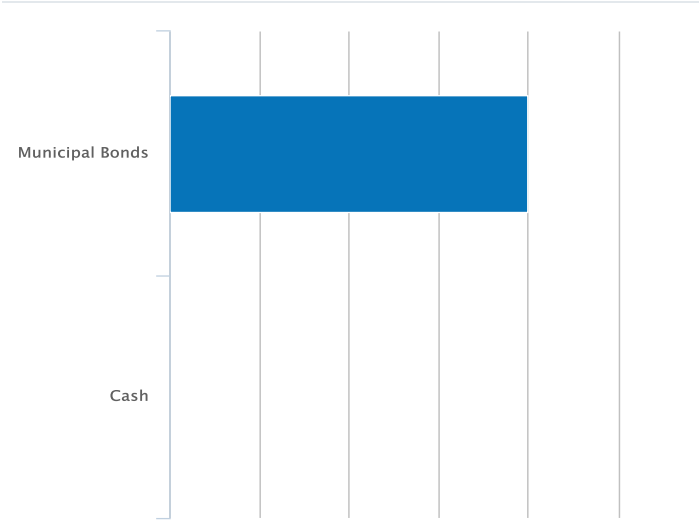

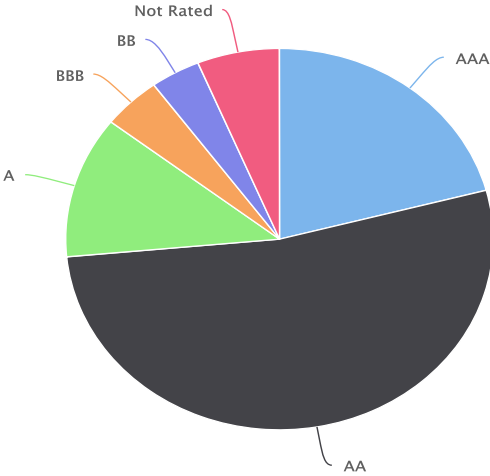

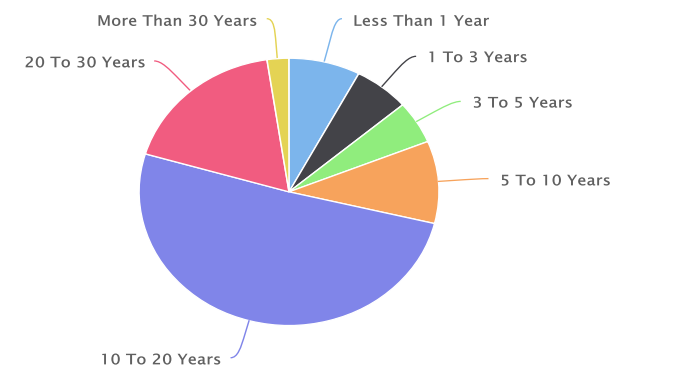
