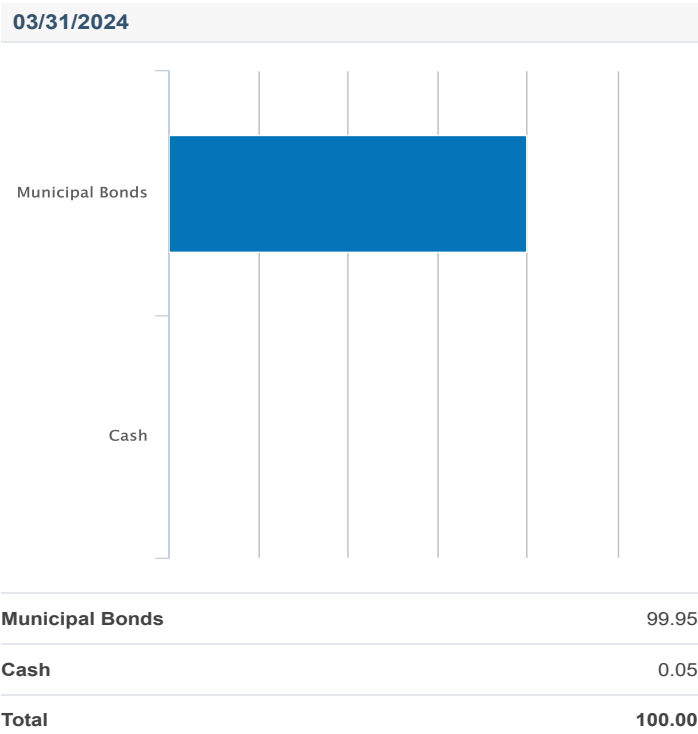

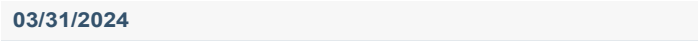

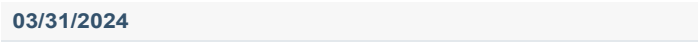
Credit Quality (%)¹²

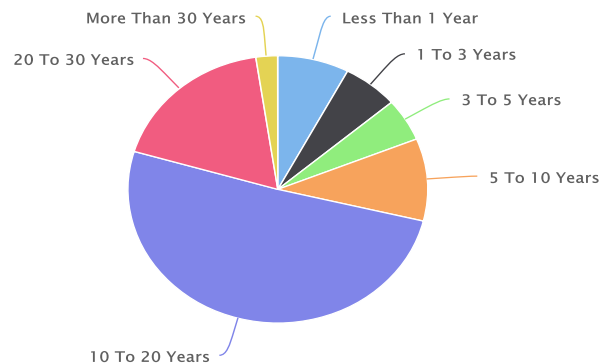
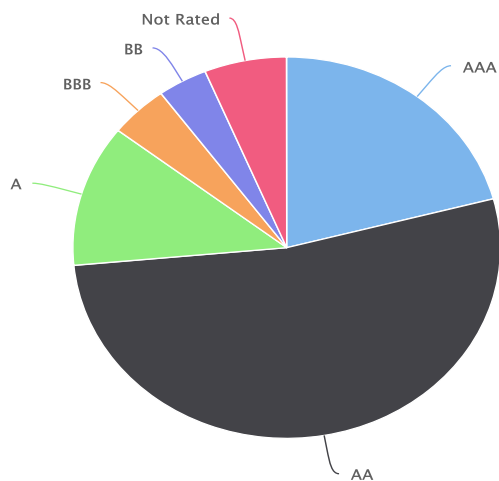
