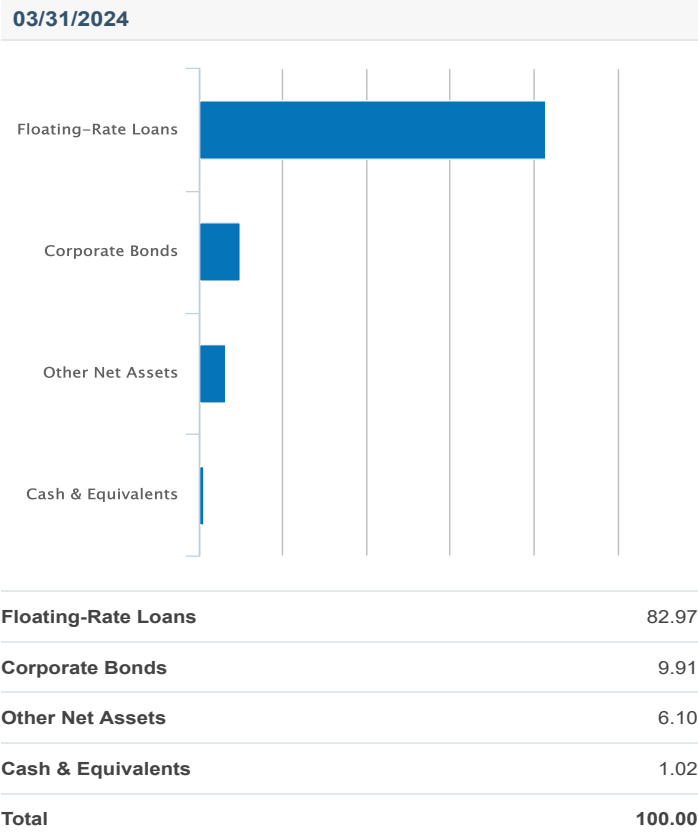

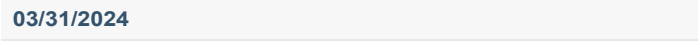

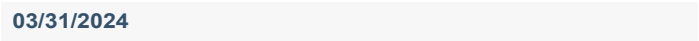

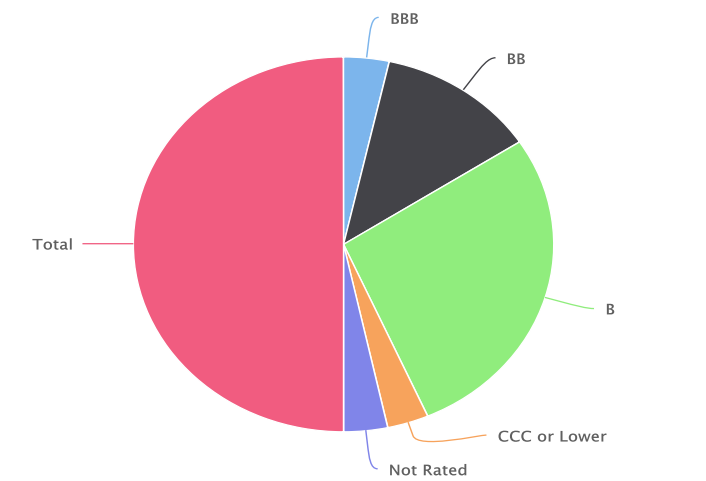

Maturity Distribution (%)^{4,9}

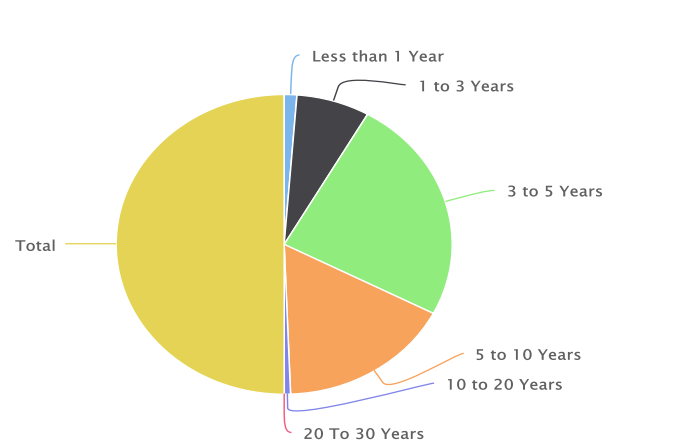
