The Features

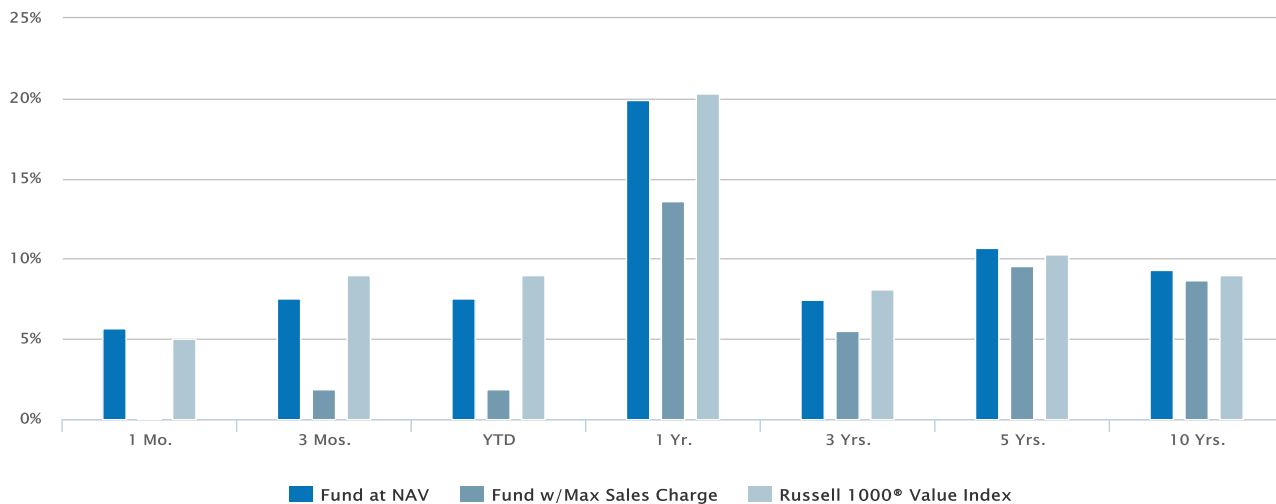

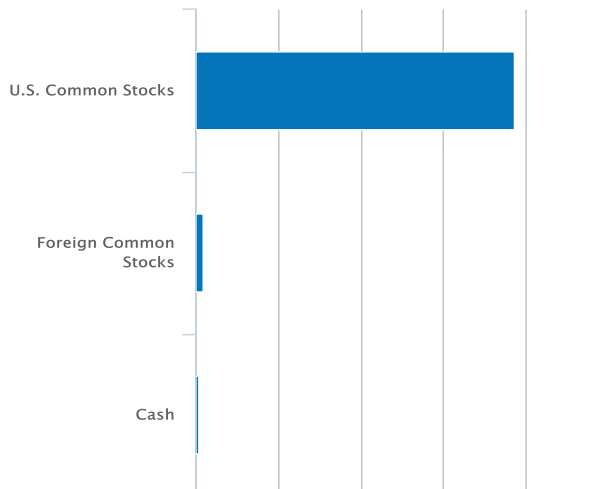

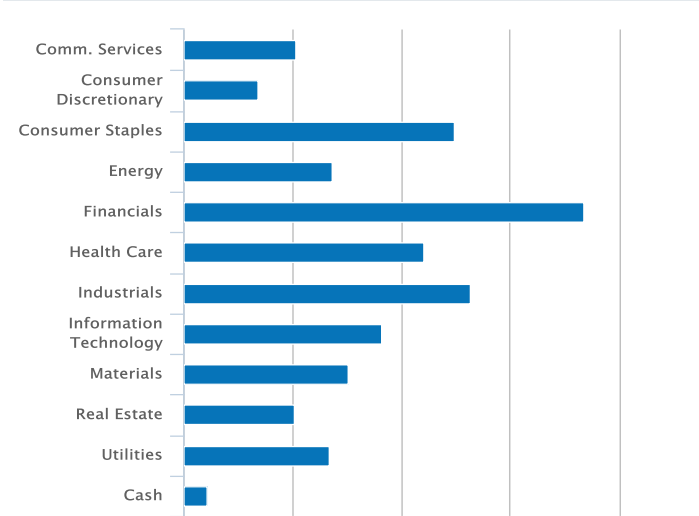
