## The Features

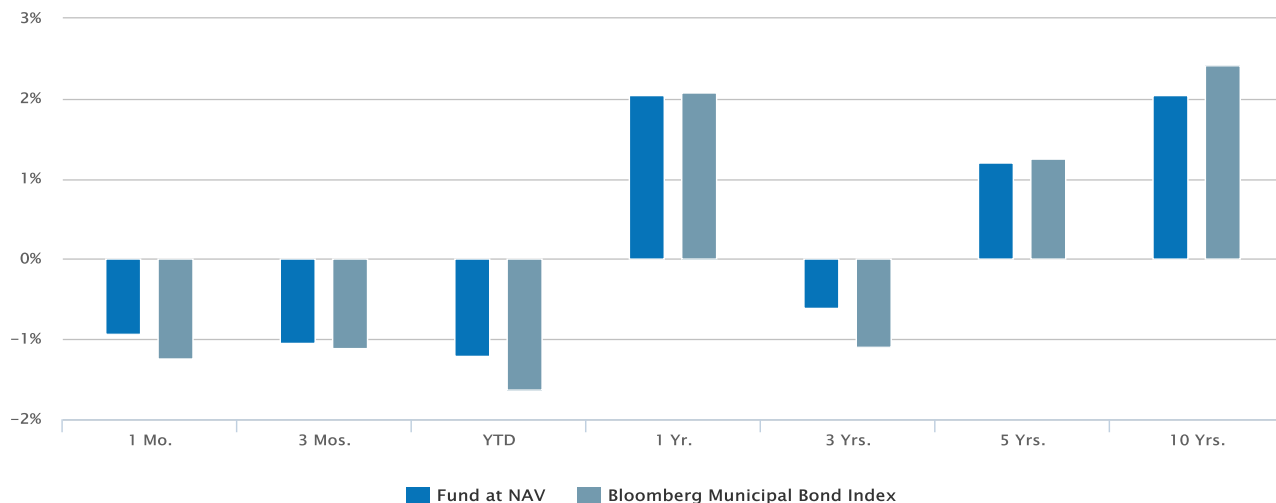

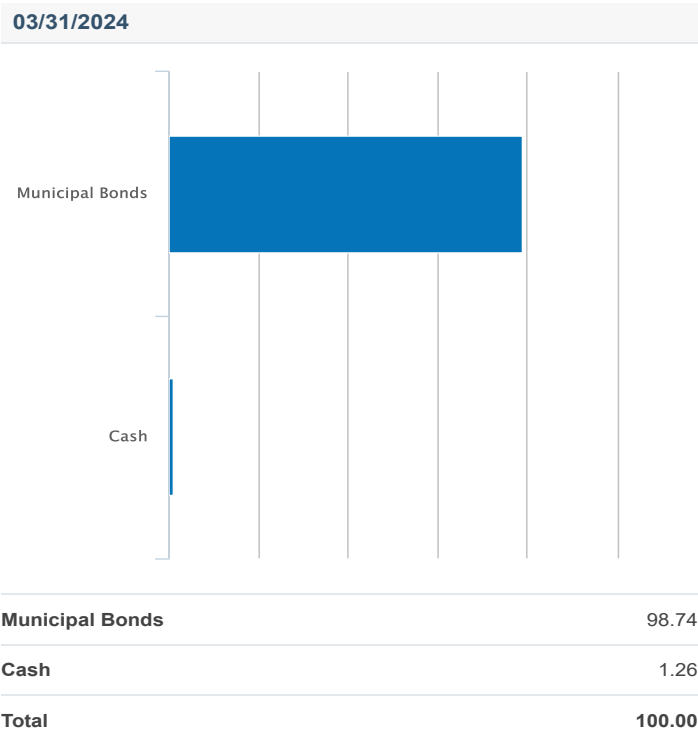

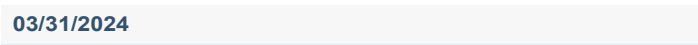

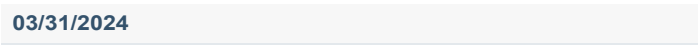

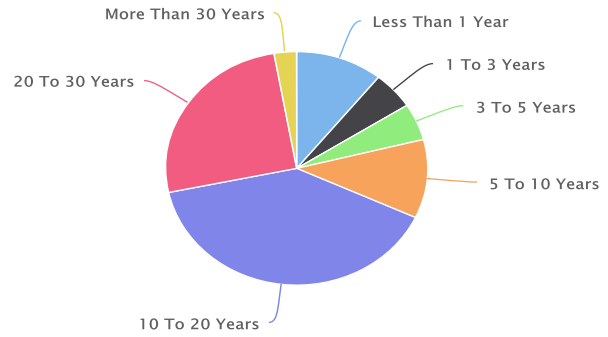
