## Comparison of Mutual Funds, ETFs and SMAs

Although mutual funds, ETFs and SMAs share many of the same characteristics, there are several distinguishing features to consider.

	Mutual Funds	ETFs	SMAs
Customization	No	No	Yes, allows for the exclusion of individual holdings based on investor preferences.
Funding	Cash	Cash	Cash or in kind
Tax Treatment	<b>Tax Inefficient</b> Trading activity from rebalancing and redemption can cause capital gain allocations to investors.	<b>Tax Efficient</b> Fund structure enables the mitigation of capital gain realization caused by rebalancing and redemptions.	<b>Tax Managed</b> Holding individual securities allows an investor to elect for loss harvesting* and enables better control of gain realization.
Locations to Consider	Tax deferred and tax exempt accounts	Either tax deferred, tax exempt or taxable accounts	Taxable accounts
