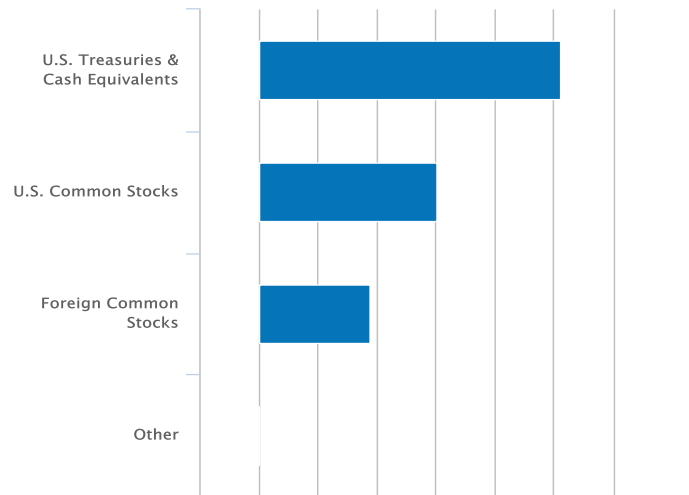
Asset Mix (%)¹

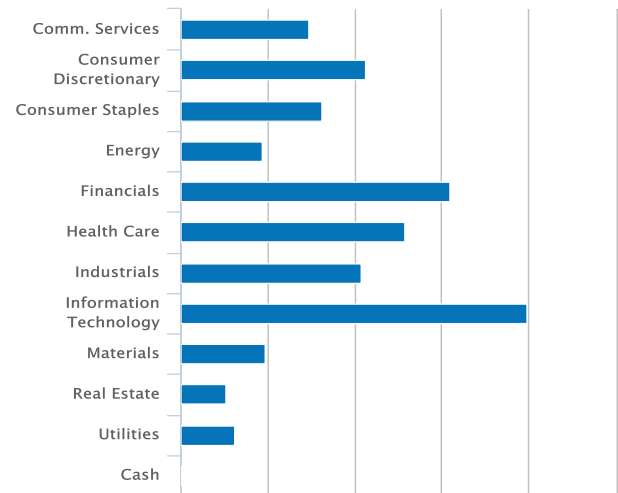

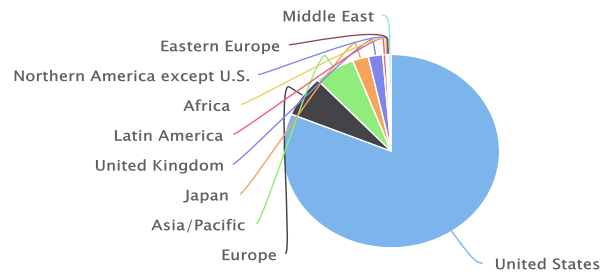
