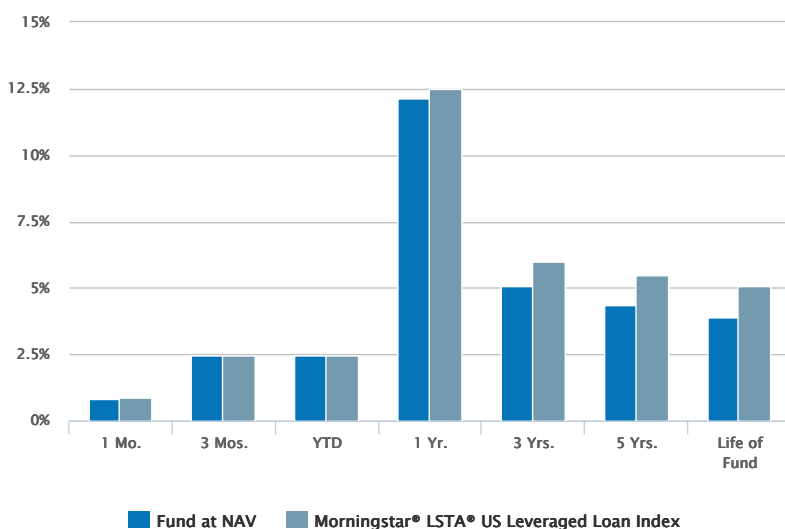

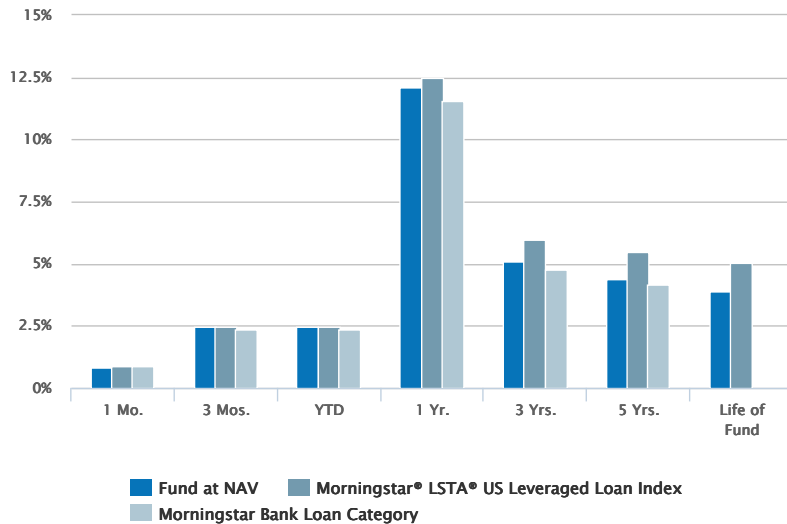

Asset Mix (%)⁴

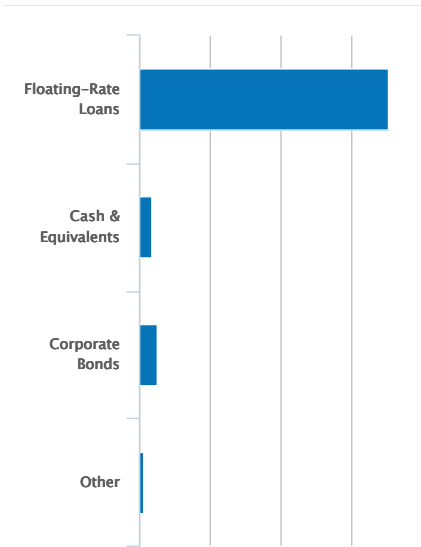

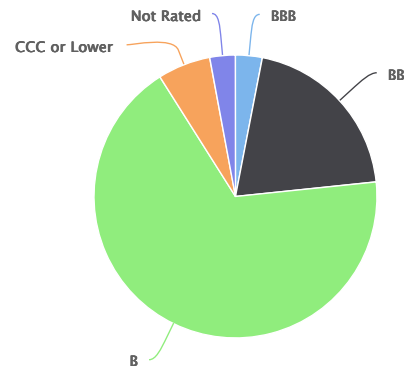

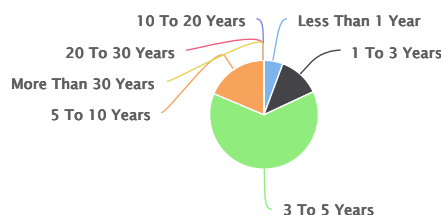

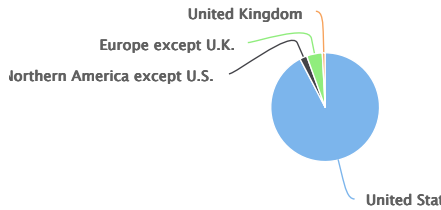
