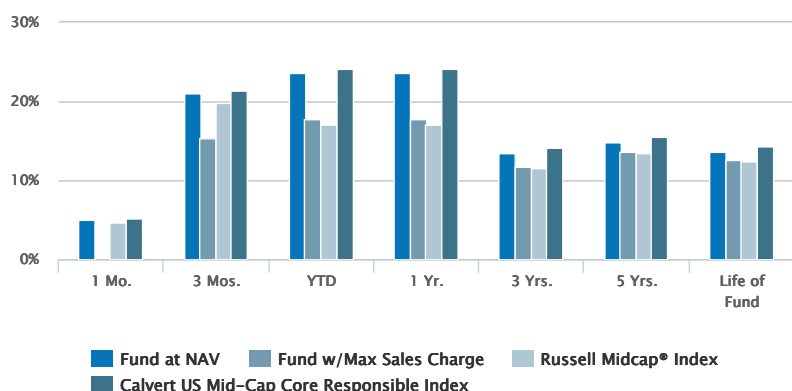

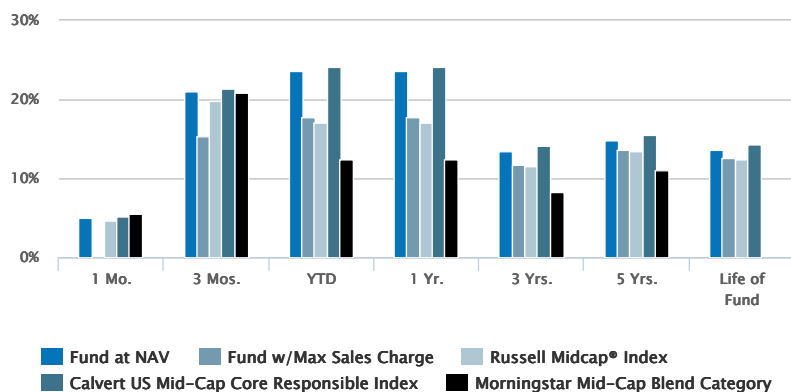

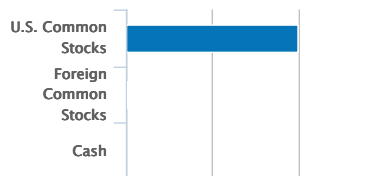




Asset Mix (%)<sup>6</sup>

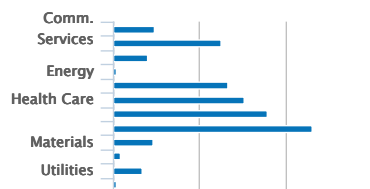
