## The Fund

This offering provides exposure to the Maryland municipal bond market, seeking to provide Fund shareholders with current income exempt from regular federal income tax and state personal income tax. Fund investments span municipal sectors and credit tiers, with allocations directed by portfolio managers.

## The Approach

The Fund's active management draws upon the expertise of Eaton Vance's municipal bond team, among America's largest and most experienced municipal bond managers. The investment team applies Eaton Vance's credit research process, while implementing a relative-value trading approach to municipal investing.

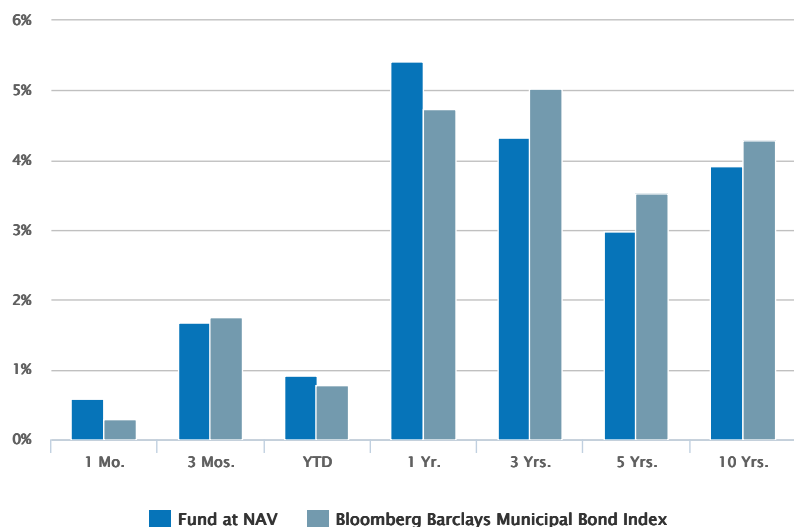
## The Features

Invests in longer-maturity bonds than many peers, which may provide higher levels of tax-exempt income<sup>1</sup> and greater price volatility.
