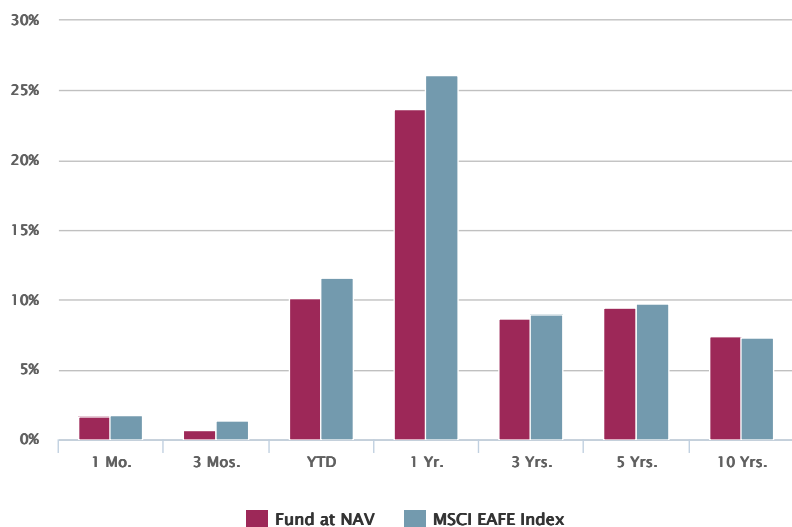
## The Features

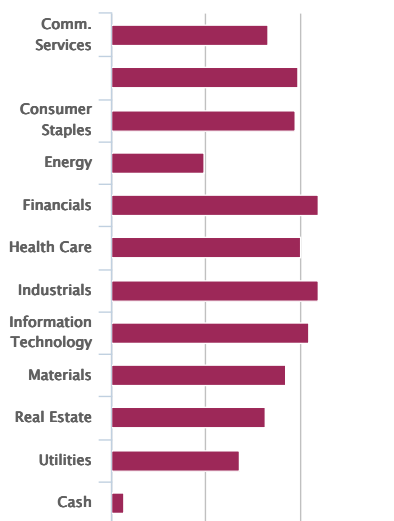
