## The Features

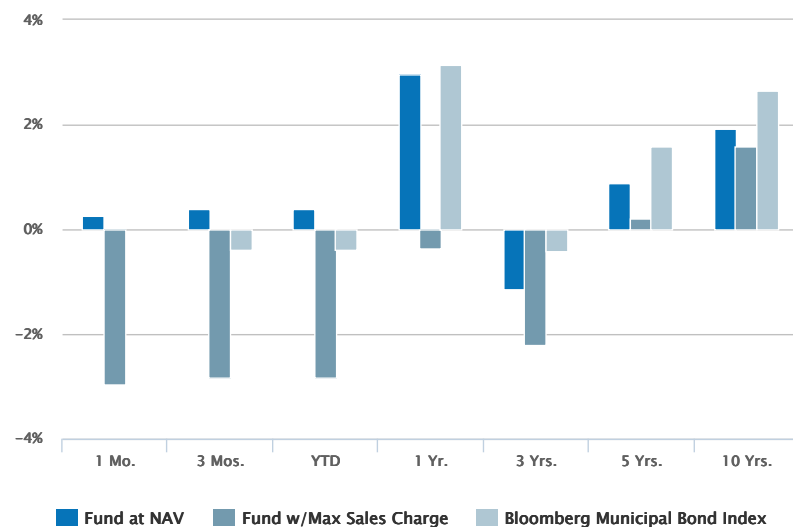

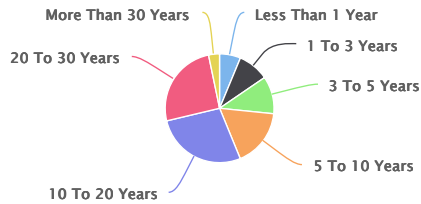
