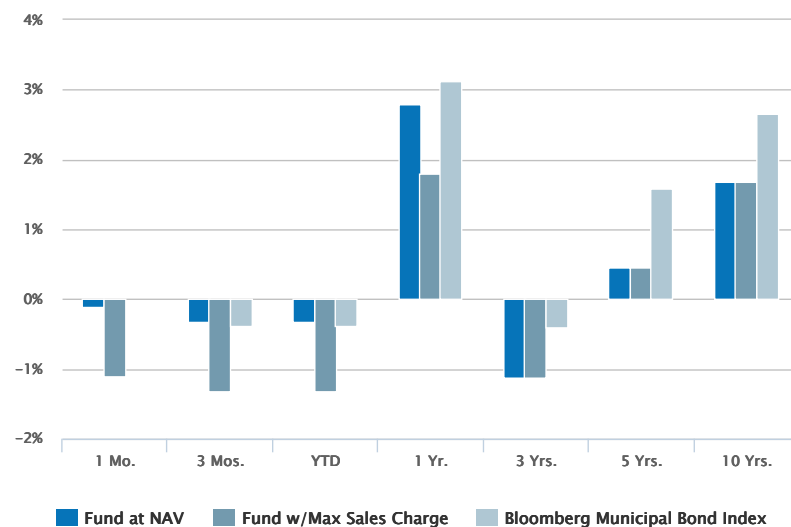

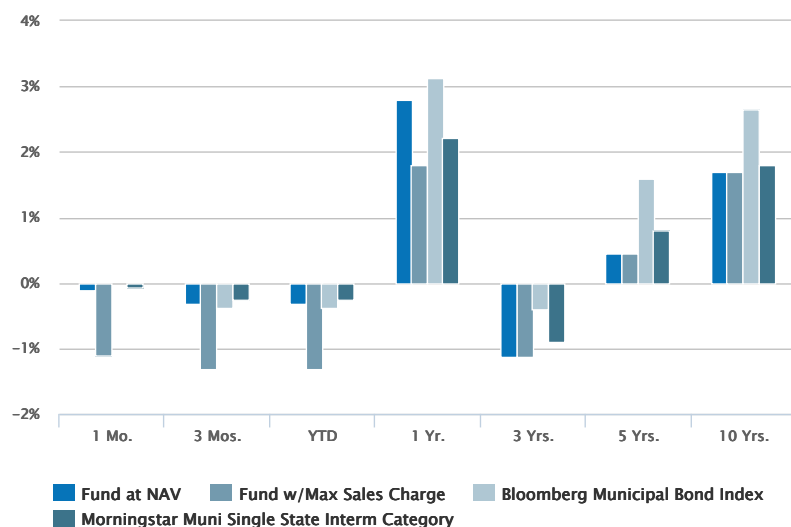

The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds and exchange-traded funds) with at least a three-year history. 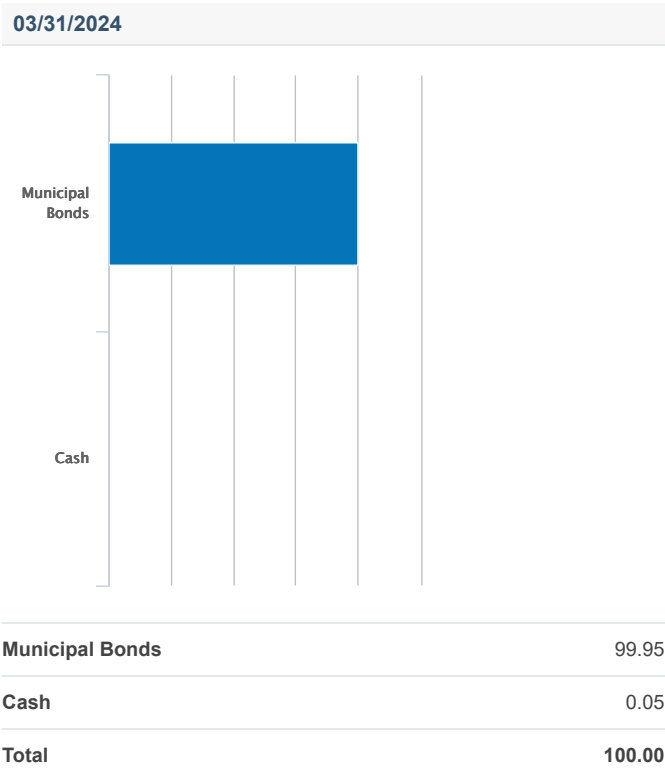

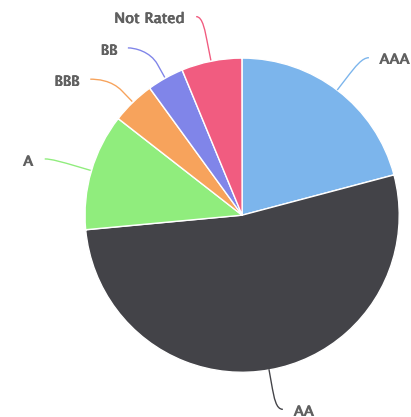

## Maturity Distribution (%)<sup>12</sup>

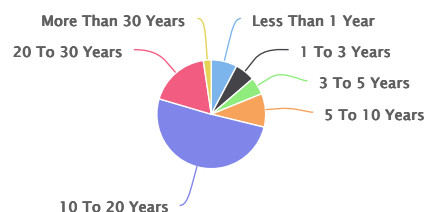
