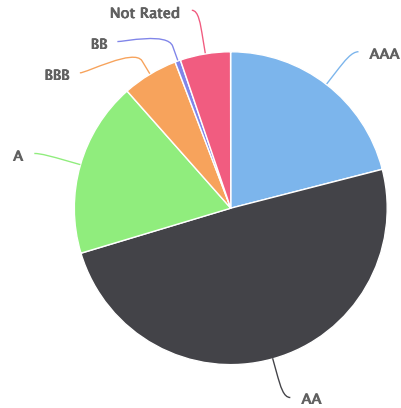

## Maturity Distribution (%)<sup>11</sup>

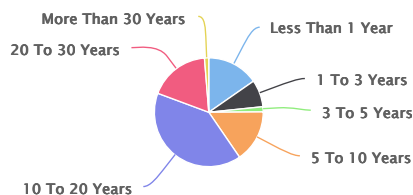
