## The Features

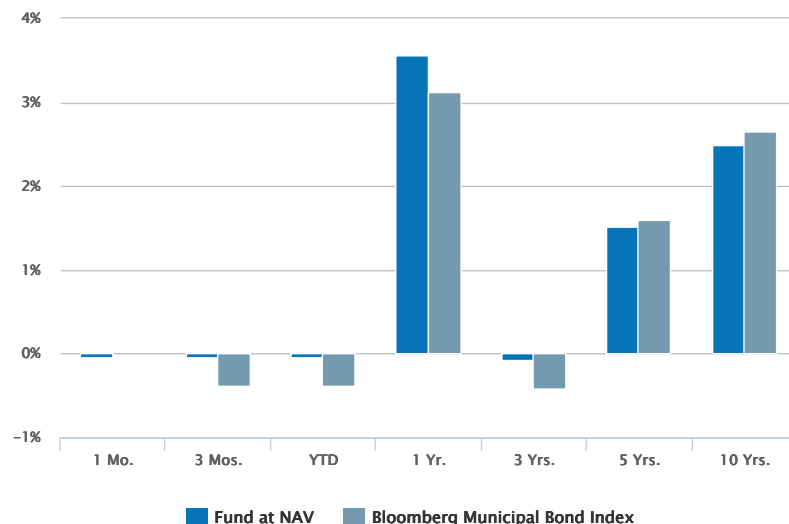

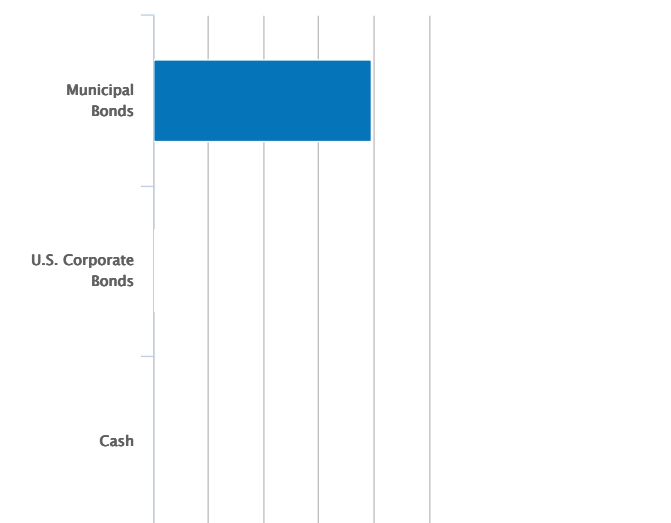

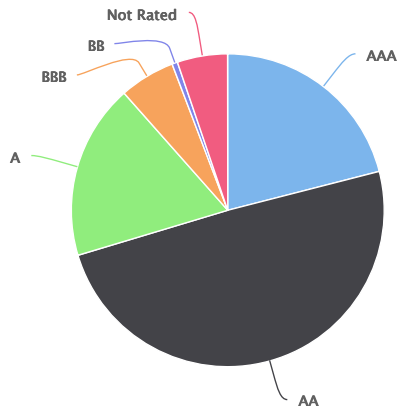

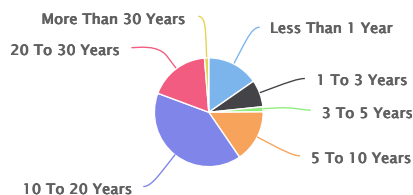
