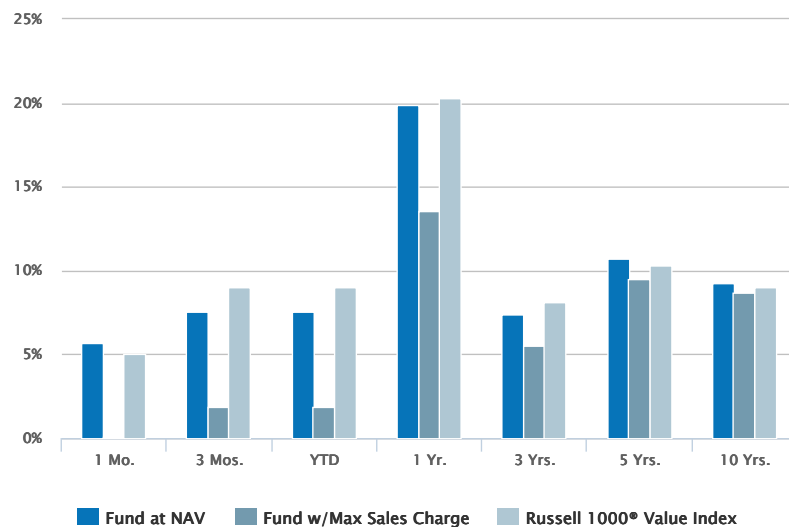
The Features

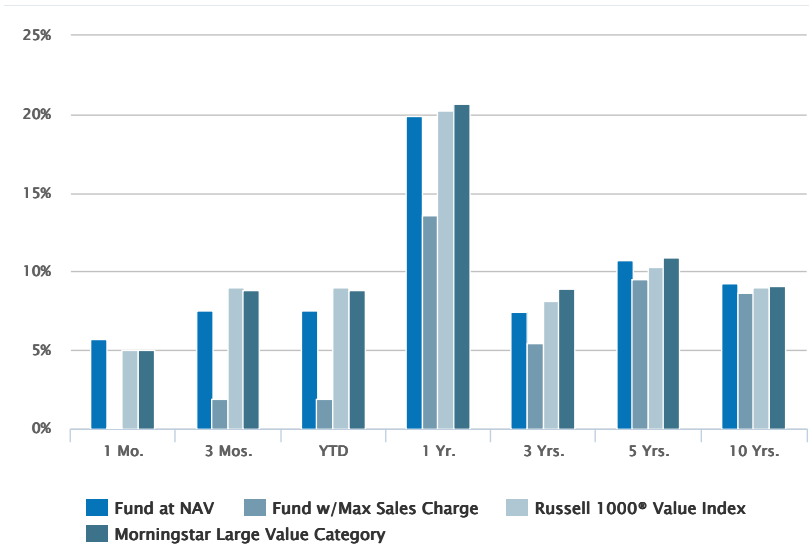

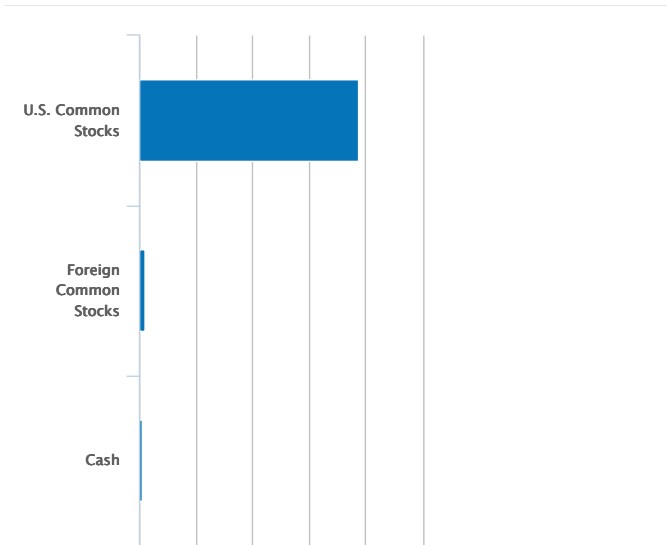

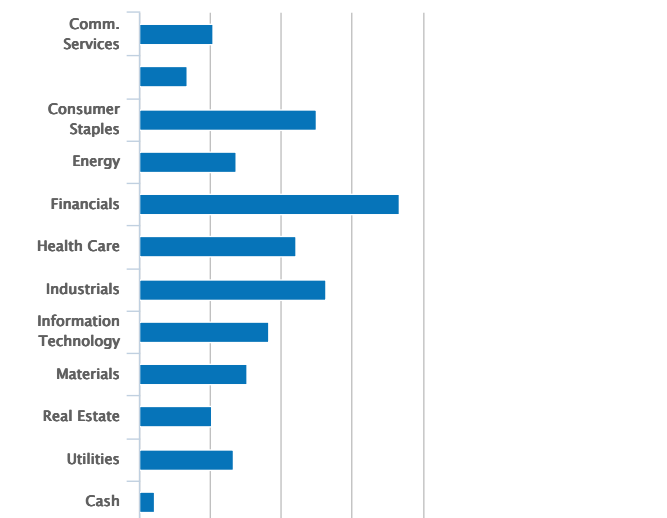
