## The Features

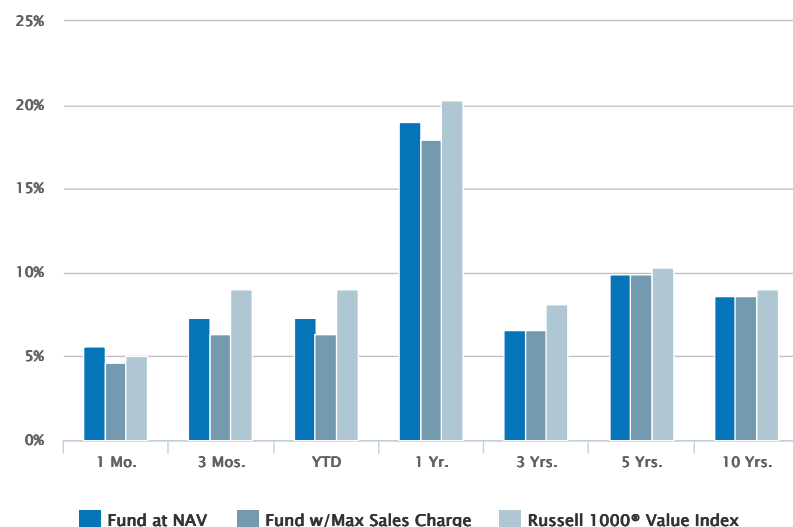

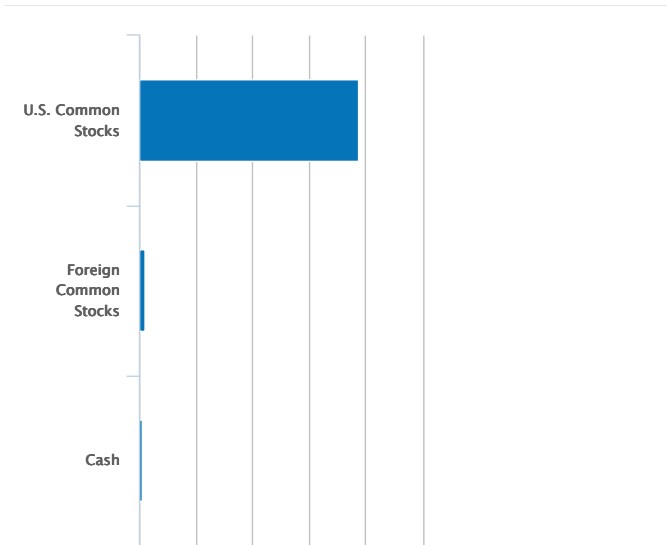
